2010 TASTE AT MUCKLESHOOT

On August 18th, the 2010 Taste at Muckleshoot was held at the White River Amphitheatre. The weather was perfect for the estimated 650 people who enjoyed a variety of multi-cultural food and entertainment. In addition to the Tribal community, representatives from 50 different partner nonprofits serving communities from Olympia to Snohomish County as well as elected officials gathered together to an evening of friendship, food, and entertainment.

The Taste at Muckleshoot was initiated last year by Councilmember Charlotte Williams to further the Tribe's partnership with communities of color and to celebrate this region's cultural diversity. With the success of last year's event, the number of attendees for the 2010 event had outgrown the capacity of the Pentecostal Church, so Taste at Muckleshoot was moved to the White River Amphitheatre.

Over 15 different dishes were provided by the Tribe and the participating nonprofit organizations. Examples included Salmon, Fry Bread, Lumpia, Asian Noodles, Jambalaya, Enchiladas, and Curry Meatballs, to name a few. Fresh fruit and five varieties of bakery cookies were also available for those with a sweet tooth.

Wonderful performances were provided by the **Muckleshoot Canoe Family**, **Naby Camera** (master griot musician from Guinea, West Africa), **Tepora Salanoa** (Samoan Dancers), **Northwest Taiko** (Japanese Drummers), and **Danza Mexica Cuahtemoc** (Aztec Dancers).

Critical to the success of this year's event was the leadership and support from Tribal Council and the hard work and dedication of Muckleshoot staff members Ada McDaniel, Mardee Marquard, Madrienne Salgado, Grant Timentwa, Faline Marsette, Josie Benito, Facilities, Job Corps, the Muckleshoot Youth Workers, Center for Career Alternative Youth Workers and dozens of volunteers from various communities throughout Western Washington.

Muckleshoot Adventures Camp 2010

Muckleshoot Adventures Camp (MAC) was held in August this year, with a different layout. We could no longer use the Outdoor Adventures program due to costs and wanting to get more tribal members involved with the camp.

Therefore we selected the site of Black Lake Bible Camp, in Olympia. It had the perfect set up to host this year's camp. The lake was beautiful, and a good setting for swimming and fishing.

The first two-and-a-half days was devoted to the children ages 7 -12 years of age, the second two-and-a-half days was devoted to 13-18 years of age and sibling groups.

The kids did classes on Personal Hygiene, Safety, Budgeting, Communications, arts and crafts, from weaving cedar to beading and the second group made drums. Swimming was an everyday activity, along with fishing at 6 a.m. in the mornings. Some evening fishing was also scheduled, as well as paint balling, archery, miniature golf, and an evening camp fire with s'mors.

I would like to take this time out to thank all the parents who allowed their children to go. They had a great time. Noosa Beach romps in Muckleshoot Tribal Classic

EMERALD DOWNS – As Tommy McJoe stood alone in the winner's circle before the 7th race on Washington Cup Day, September 12, the track announcer's voice boomed out over the Emerald Downs PA system:

"Our honorary steward for the Muckleshoot Tribal Classic is Tommy McJoe, a Muckleshoot tribal elder and former member of the Longacres jockey colony. From the time he was just a tyke, Tommy rode horses high up into the mountains to pick huckleberries..."

Reading from the prepared script, the announcer told how Tommy went on to become a jockey at Longacres back in the mid-'50's, and how he continued to work with horses at racetracks throughout the West for the next 14 years.

It was the third year in a row that Tommy has served as honorary steward for the \$50,000 Muckleshoot

Tribal Classic, a job that consists mainly of awarding a trophy to the winning horse's connections. Formerly known as the Washington Championship, the Classic is one of the oldest and most prestigious races in the Northwest.

Tommy was pulling for Wasserman, an 8-year-old son of the great Cahill Road that has won more than a half-million dollars at Emerald, hoping he'd win for the third year in a row. But there's a new kid on the block this year – a four-year

sensation named Noosa Beach that has been almost unbeatable, winning four major stakes, including the \$250,000 Longacres Mile.

When the gate sprang open, it was Noosa Beach all the way as he capped off the most spectacular season in Emerald Downs' history with a 2 3/4-length victory, setting a new track record with his fifth stakes win and boosting his 2010 bankroll to \$225,930.

Wasserman, as usual, lagged far behind the pack, waiting until the

final turn to launch his bid, and then passing one horse after another for a second-place finish – his best performance of the year.

"We are very proud of Noosa Beach," trainer Doris Harwood said afterwards. "This is going to be his last race of the year, so we're delighted to be the winners, and to represent Washington, and we just want to thank the Muckleshoot Tribe for all it does for horse racing."

2010 Family Fishing Derby Highlights

The sights and sounds were familiar as Tribal members young and old cast their lines into the Keta Creek trout ponds for the Family Derby held on August 14th. It was a beautiful summer day; over 350 people came to the hatchery to participate in the activities. Those that came early got to pick out their favorite spot to set up chairs by one of the three trout ponds. Fishing for all ages began promptly at 10am. Those not fishing became part of the support team; standing with nets ready to help haul in the catch, untangling lines, and putting bait on hooks. All fish caught, big and not so big, were carefully put in bags with ice to be taken to the weigh-in tent. After 12 o'clock when fishing ended, and fish were weighed, hungry fishers headed to lunch to fill their plates with hamburgers, hotdogs, and corn-on-the-cob. Since the temperature was going up there was also a line for the ice cream and toppings.

Everyone gathered around the stage area to see who would take home a prize for catching the biggest fish. First were the drawings for door-prizes done by our Fisheries Enhancement Manager, Dennis Moore. He also announced the winners for the casting contest that was held in the morning. Alan Stay, from MIT Legal, presided over our new contest for Paper Airplane Folding and Throwing while the crowd waited for the fish weigh-in to be completed. Three winners were chosen from the contestants who got their skillfully crafted airplane to fly through the Hooola-Hoop target. Finally the prizes for 'Biggest Fish' were announced by Hugo Hernandez, the Keta Creek Hatchery Team Leader. Fifteen prizes were awarded for fish weighing in from 10lbs-5oz to 6lbs-4.5oz. Prizes included an iPod Touch, resort gift certificates, a family tent with sleeping bags, patio set, and other great items.

After lunch it was time for Richard Johnson, White River Hatchery Team Leader, to help the kids break open two candy-filled piñatas in the traditional manner of being blindfolded, spun around, and trying to hit it with a baton. It was the usual mad scramble for the candy that fell into the grass.

Northwest Indian College announces successful accreditation as four-year degree granting institution

LUMMI – Cheryl Crazy Bull President of Northwest Indian College, a tribally-chartered college of the Lummi Nation, is pleased to announce that NWIC was recently granted accreditation at the baccalaureate degree level and was reaffirmed accreditation at the associate degree level.

With this affirmation as a four-year degree granting institution, NWIC, the only accredited tribal institution in the Pacific Northwest, is a comprehensive post-secondary institution better able to fulfill its vision of place-based education for all Native people, especially in the Pacific Northwest. The college seeks to strengthen its model of continuous improvement, advancing the quality of life for all northwest Indian communities by encouraging, preparing and promoting Indian people to successfully complete secondary and post-secondary education.

The Northwest Indian College has been an accredited two-year post-secondary institution since 1988. The College was granted accreditation by the Northwest Association of Schools and Colleges effective September, 1993. On May 2, 2007 the Northwest Commission on Colleges and Universities granted Northwest Indian College candidacy status at the baccalaureate level and reaffirmed accreditation at the associate degree level in January 2009.

The commission's recent accreditation of NWIC at the baccalaureate level includes the College's Bachelor of Science in Native Environmental Science (BSNES). Northwest Indian College voluntarily engaged in a comprehensive self-study review process as a 4-year degree granting institution, by which institutional accreditation was granted by a regional accrediting agency within the scope of authority of the U.S. Department of Education. Institutional accreditation applies to the college as a whole, not individual programs or units within the institution. The effective date for accreditation at this programming level is Sept. 1, 2008.

The development of NWIC as a bachelor's degree granting institution has been a shared community vision and ongoing goal of the college since the inception of Northwest Indian College. Throughout the College's his-

tory, the Board of Trustees, tribal leaders and NWIC faculty, staff and students have worked together to develop academic and social programs that meet the emerging and evolving economic and human development needs of tribal communities.

"I'd like to congratulate and thank all of you – your work, support and prayers made this possible," Crazy Bull said. "Generations of tribal students will benefit from our ability to support their professional education. Our focus on our tribal mission and the mandate we have to provide a culturally sound, high-quality education has brought this success to bear.

"The Commission restated their commendations of the College's devotion to mission, applauds the 'community' that the College is, and recognized the successes we have had with our campus development, fundraising and with the new Center for Student Success."

Northwest Indian College's main campus is located at the Lummi Nation with extended campus sites at Swinomish, Muckleshoot, Port Gamble, Tulalip and Nez Perce. Over 1,300 students participated in NWIC programs and services in the last academic year. NWIC is the largest provider of educational services for adult Native people in the Pacific Northwest.

New GED Orientation Information and Schedule



Beginning in June, GED registration procedures changed to ensure that testing time is utilized efficiently for all students.

- The first FULL week of every month registration and orientation will be required for all GED students. This process will take approximately 20 minutes. The process will include completing all registration forms to avoid delays on testing day. Call or come to the college to sign up.
- Students will only be allowed to participate in GED preparation and testing if they have registered and attended one of the orientation sessions. Students must submit all completed forms/registrations and required information and payment (if applicable) to the GED examiner on testing day.
- At the orientation, all students will be asked to sign up for an evaluation/assessment appointment. Please allow for approximately 1 1/2 hours for your evaluation appointment.

Any student who does not have all the completed forms and required documents prior to their testing time will be asked to return on another testing date and will not be allowed to test.

This chart displays the most Abused Pharmaceutical Substances as reported by the National Association of Drug Diversion Investigators, Inc. The bold letters on each category represent the generic name of the drug. Below it is the name brand. On the Muckleshoot Reservation the most common abused drug is OXYCODONE (OXYCONTIN) 80mg. Remember, it is illegal to share prescription medications. Medications must be carried in the original bottle, with the original label indicating the

name of the person, drug, strength, and Dr. Prescription medications cannot be mixed together into one container. Any deviations from this can result in you being arrested for a felony and face charges of Violation of the Uniform Controlled Substance Act (VUCSA). You can do an internet search and find a wealth of information. If you have any questions, please contact any member of the Muckleshoot Police Department.

- Sedatives:** Xanax (Alprazolam), Valium (Diazepam), Lorazepam (Ativan), Clonazepam (Klonopin), Zolpidem (Ambien), Phenobarbital (Luminal).
- Antidepressants:** Sertraline (Zoloft), Fluoxetine (Prozac), Venlafaxine (Effexor), Duloxetine (Cymbalta).
- Other:** Gabapentin (Neurontin), Pregabalin (Lyrica), Tramadol (Ultram).

Q & A about the Muckleshoot Police Storefront Office

REPORTING A CRIME OR SUSPICIOUS ACTIVITY? DIAL 9-1-1

Lately, we've received some phone messages expressing frustration that "we" are never here (police department) to answer the phone, so I thought I would take this opportunity to explain a little of what the Storefront Office does.

If someone is trying to report a crime or suspicious activity, it's imperative that you call 9-1-1. We understand the frustration that comes from doing this and the 99 questions that the call receivers ask, but, it's extremely important that 9-1-1 is called.

One reason is some calls for service require more than one officer to respond for officer safety, such as Domestic Violence or Burglaries in progress. The call receivers are trained to ask questions to determine what kind of police response is necessary.

Different types of calls require different responses and they are screened by the call receivers as to their priority. Crimes that are "in progress" (happening at the time of the call) take priority over calls those are not life-threatening.

Valuable time is wasted by calling the storefront office, only to find out no one is there to take your call. The storefront is not a dispatch center. We do many things, from responding to calls; attending meetings, patrolling the community, putting on a presentation, just to name a few.

If you live **within the City limits of Auburn**, regardless of whether you are on the reservation or not, Auburn is the police agency that will be responding to your call. Muckleshoot Deputies respond to calls in the unincorporated portion of the reservation which starts about SE 386th St. (Hamilton's Corner).

If you need to speak to a Muckleshoot Deputy, still call 9-1-1. The deputy's cell phone numbers are **NOT** to report an emergency. The deputy's schedules vary with days off; training, etc. so calling 9-1-1 will ensure you get a return phone call from a Muckleshoot deputy.

Last, but not least, if you call 9-1-1 from your cell phone, there is a chance that you will be talking to a call receiver from a different police agency and you may need to be placed on hold to transfer you to the agency you need.

Emergency calls from cell phones can go to the nearest/strongest signal that may connect you to - either the State Patrol or Valleycom dispatch. Simply let the dispatcher know where you are, or where the incident occurred and they will get you connected with the right agency.

Suboxone (Sub-ox-own) referrals and treatment now available @ HWC!

Help for prescription pain medication dependence is now being offered through the Health and Wellness Center. Suboxone is also used in the treatment of other opiate-based or synthetic opiate drug dependence. These drugs include: Oxycodone/Oxycontin, Hydrocodone, Vicodin, Heroin, and Morphine.

SUBOXONE is the first opioid medication approved under Drug Addiction Treatment Act (DATA) 2000 for the treatment of opioid dependence in an office-based setting. The primary active ingredient in SUBOXONE is buprenorphine.

SUBOXONE at the appropriate dose can:

- Reduce illicit opioid use
- Help patients stay in treatment
- Suppress symptoms of withdrawal
- Decrease cravings for opioids

The Health and Wellness Center has a medical provider licensed to prescribe suboxone.

The eyeglass benefits are the same as they've always been. One comprehensive eye exam once every 12 months. New lenses once every 12 months. Adults eyeglass frames once every 2 years/children 2 per year.

If you are not eligible for the frame allowance, you will be allowed to purchase the frames at a very reasonable price. (Believe me there is a significant mark up when you buy frames in town/private practice!). No eyeglass benefits will be approved outside of the MHWC optical department. We are also offering contact lenses and necessary supplies for contacts.

The Optical Department is a Tribally-owned business. Patients must meet CHS eligibility requirements to get optical services. CHS eligible patients will need to obtain a PO from the CHS office before getting optical services.

CONTRACT HEALTH SERVICE (CHS) NOTIFICATION REQUIREMENTS

CHS OFFICE
(253) 939-6648

1. Notify CHS office before any non-emergent services are rendered to determine patient eligibility, medical priority and to set aside funds for payment. Pre-authorization is mandatory and failure to comply is reason for denial of payment for claim(s).
2. In true medical emergencies, notify the CHS office within seventy two (72) hours of start of services. Failure to comply is reason for denial of payment of claim(s).
3. Prior notification does not guarantee CHS can pay for services, unless all other CHS requirements are met. There are some services CHS can not cover.

ALTERNATE RESOURCE REQUIREMENTS:

Muckleshoot CHS is a residual resource and not an entitlement program. In addition to CHS, other resources for health care are available from various state, and federal programs, as well as individual and group health insurance policies. By federal law, CHS must ensure that all resources, where and when applicable, are utilized before CHS can assume financial responsibility for your care.

This means that CHS will not be authorized if you are eligible or would be eligible upon making an application for an alternate resource such as: Medicare (over age 65 or disabled at any age), Medicaid (medical coupons), crippled children or have private insurance etc. Failure to comply with a CHS office referral to an alternate resource will terminate your CHS coverage. You are required to use these benefits as your first source of payment of your medical-related costs.

The CHS office is required, as per IHS Federal Rules and Regulations, which requires all CHS denials to patients be sent by certified mail to the address on file.

Notice:

In an effort to better serve you better, we are making some changes to the walk-in clinic and medication refill guidelines. These changes took affect Dec. 15th, 2008 and include:

- Walk-in Clinic at 1 pm M-F will be seen based on medical need—not on a first come, first serve basis.
- Patients presenting for walk-in will be checked on their Registration status. If necessary, you will need to update your application.
- The walk-in clinic will no longer be used for pain medication refills. Please see your provider for refills.
- Lost or stolen narcotics will no longer be refilled.

On Eagles Wings

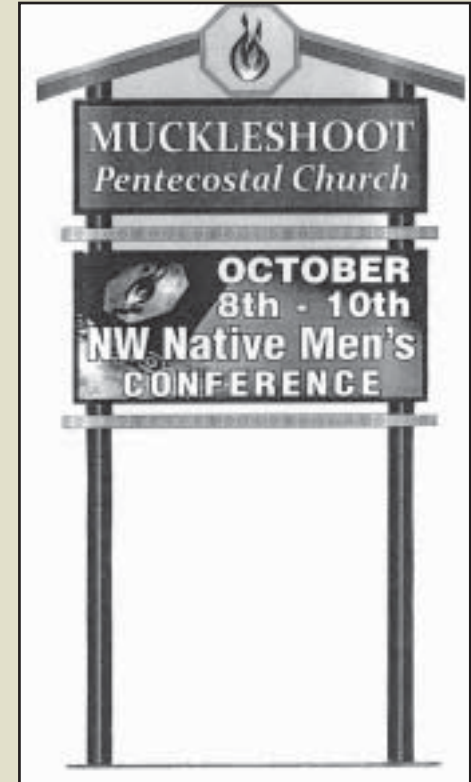

Hours of Operation:

The Public Works operate a Solid Waste Collection Station located at 40320 Auburn / Enumclaw Rd., (Entrance from So. 400th Street)

Monday- Friday: 8:00 AM - 3:30 PM
 Saturday-Sunday: 1:00 PM - 5:00 PM
 Holidays: Closed

Policy:

- The facilities are free and restricted to all MIT Tribal members use only. (No exceptions.)
- No commercial vendor or contractor shall use this facility for commercial waste.
- All waste shall be put in the specific designated locations or bins. Repeat violators may be barred from further use of the facility.
- All members shall keep the ground clean at all times. Report any spills to the office immediately.

Housing Tenants:

All Housing tenants must request dumpster service through MIT Housing Department. Please call 253-833-7616.

How to Request a Dumpster:

Members who are either home owners / renters can request dumpsters to be delivered to their site for a special cleaning project. Members are required to come in to the Public Works office during the business hours to fill out a Work Request form after obtaining approval from the Housing Department. Dumpster size ranges from 3, 5 and 8 cubic yards. Larger size is available upon special request.

No mixed waste shall be allowed in each dumpster. Yard waste, garbage, appliances and electronic items shall not be put in the same dumpster. Members with mixed waste are requested to bring their items to the Public Works Collection Station.

Property / Site Clean up:

Code Enforcement may require the land owner to clean up their property. Dumpster can be requested to be delivered to facilitate the project. Please call the PW office to request a dumpster for the project. For salvage vehicles removal, please call Planning Dept. Lenny Sneatlum at 253-876-3324.

Demolition Projects:

Should a home or any structure / trailer needs to be demolished, please first obtain a demolition permit from the Planning Department and then bring the permit to the Public Works Department to arrange the work to be performed.

What can you bring to the Collection Station?

- Yard Waste
- General Household garbage
- Tires, small engine, batteries
- TV, computer and other electronic items
- Major appliances
- Waste oils and paints

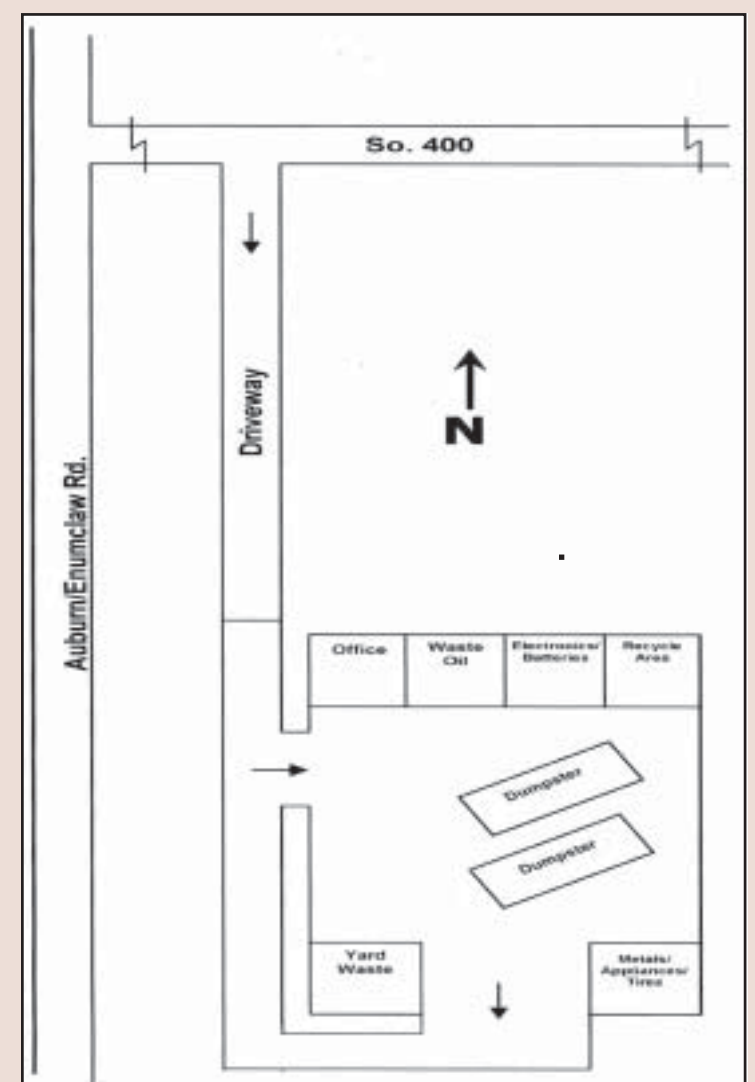
All items above shall be put in separate designated area and dumpsters. DO NOT mix the above listed waste.

Any questions regarding the use of the facilities or services, please call the Public Works Office at 253-876-3281 between 7 AM to 4 PM. (M-F).

Notes:

- A new recycle area is designated to collect recyclable waste such as newspaper, card boxes, bottles and cans.
- The Collection Station is monitored by surveillance cameras. Any violators may be cited for penalties as allowed by the MIT Codes.

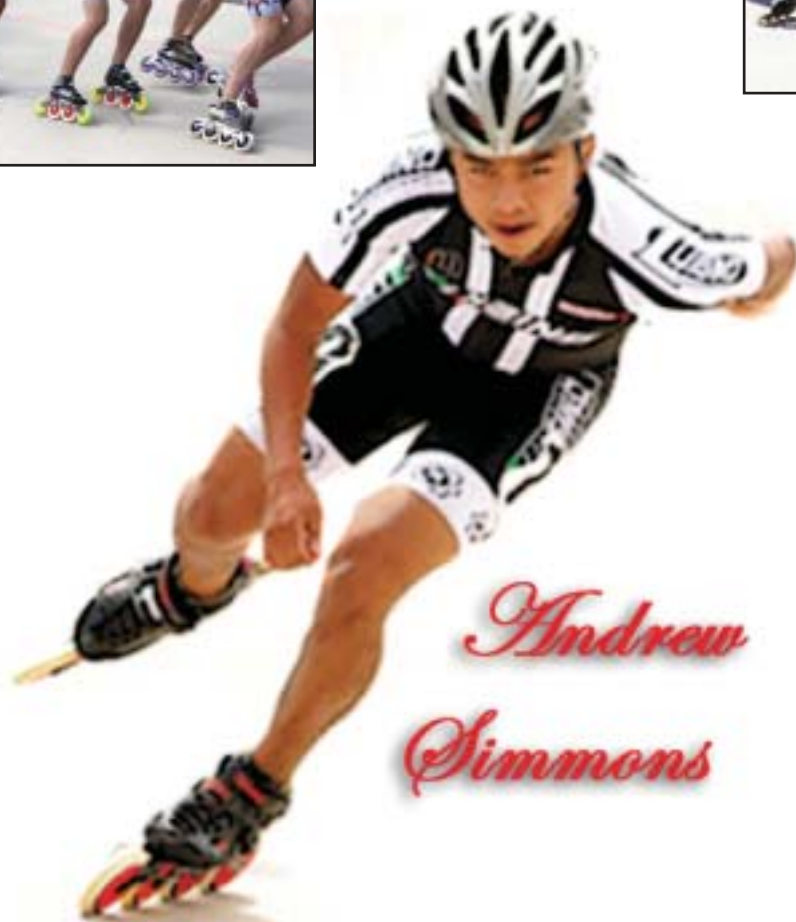

Squaxin Tribe purchasing interest in allotments on Squaxin Island

Do you own interests in allotments on Squaxin Island? The Squaxin Island Tribe's Department of Planning and Community Development is purchasing undivided fractionated interest in allotments on Squaxin Island. The BIA's Title Status Report indicates that there are at least twenty-four (24) tribes in the surrounding area who have members eligible to sell their interest(s).

The Tribe is paying individuals the appraised value of the land, the full fair market value of the timber outside established buffer zones, and 50% of the value of timber within the buffer zones.

Generally timber cannot be harvested within the buffer zones established in the Tribe's Forest Management Plan. The Tribe will only purchase interest in allotments that have been appraised by the BIA, Office of Special Trustees. Appraisals are conducted annually.

Purchasing will be conducted on a first come – first served basis. The date of your application will establish your priority status.
