## Anita Pedro is Tribe's New Human Resources Director

It seemed like it was only a matter of time until Anita would become her tribe's Human Resources Director. For such a young person, she had so many years of excellent experience in the field. Her resume' is impressive: Since starting in HR at age 18, she's spent 11 years at the casino, where she worked her way up from HR Clerk to Assistant Director; seven years as HR Director at the bingo hall; and in between, stints as a TGA Inspector and HR Analyst for Recruitment and Training for MIT's HR Department.

With a background like that, it seemed like attaining the tribe's top HR position must've been partly a matter of destiny and partly a matter of carefully executed career planning.

That's what one might think, but it didn't exactly start out that way. In the beginning it started with a peculiar bit of casino luck, and as her career has unfolded it's been very much a story that reflects the lives of many others in the Muckleshoot Tribe since the beginning of the casino era. Anita begins to tell her story:

"I was 18 years old, and I had my son, Isaac. He was a baby. I signed up for dealer training, but I found out I'd missed the deadline," she recalls. But then her casino luck kicked in. "The HR Director, Elisa Paisley, asked me if I'd be interested in working in Human Resources. I didn't know what Human Resources was, but I thought 'why not?' I needed a job to take care of my son."

And so that's how it began. Looking back on it now, Anita wonders what would've happened if she hadn't missed the deadline and had become a blackjack dealer. Would she be a pit boss today?

But then, as we all know, everything happens for a reason. The position in HR happened to be available because Kristine (KingGeorge) Osoteo left it and was in the process of adopting her daughter Alice at that time. Anita immediately showed great promise, and both Elisa and her successor as HR Director, Laurie South, mentored her as their protegee'.

"From there, I learned benefits and recruiting, and just really wanted to learn all of Human Resources, to master that area, and to learn training and development, and all there was to know," she says.

She benefitted from being a member of a strong team, which included fellow tribal members Mardee Marquard and Tanya Rojero, as well as Peter Hixon – all of whom have since made their mark on the tribe's operations. The two HR Directors she first served under, Paisley and South, were Anita's biggest boosters.

"These women were like moms to me, as well as mentors. They would continue to push me, telling me, 'You're probably going to wind up working in Seattle somewhere,' and 'You need to get your degree,' and 'You have so much potential. You need to do this.'"

After about a year, at age 19, however, Anita was offered a job at TGA earning 50% more than she was making at the casino. Finding the new job dull and unchallenging, thought, she quit four months later without any plan for what to do next. But she wasn't unemployed for long. The casino HR Department snapped her up again, and this time she stayed for another decade, working her way up to Assistant HR Director before moving on to a job at the tribal HR Department, and then the HR Director position at the bingo hall, a job she held for seven years before accepting her current assignment.

Over the years, the Muckleshoot gaming enterprises provided Anita with exceptional opportunities for on-the-job training, but there was one thing that was lacking: higher education. And her tribe provided it. While she was still working at the casino, she signed up and took some classes at Green River Community College, which placed her in a position that will be familiar to many: She was working, going to school full-time, and raising her 10-year-old son as a single mom.

"It wasn't easy," she recalls. "I would go to school and then take time off, and then take another class and try to feel my way. It wasn't easy in college, and working and going home and sacrificing that time with my son, studying. So, it took me a long time."

Eventually, friends persuaded her to try out Evergreen State College. Anita was serving on the Education Committee at the time and was familiar with the program. At Evergreen, Jeff Antonellis-Lapp became yet another positive mentor that helped her on the path she had chosen.

Meanwhile, in the midst of it all, life continued to happen. Anita's fam-

Thousands gather on the beach every year for this family event that allows boys and girls dressed as pirates to meet "real" pirates – AARGH!!! – and make memories that will last a lifetime.

The whole event went smoothly for all, and the pirates were thrilled to share the day with the Native canoe families. Many of them jumped onto canoes from their cannonaded pirate barge and landed on the beach in the old-fashioned way with the Natives. It served as a good tune-up for the main event, which is soon to begin – the 2012 Paddle to Squaxin. Here is Muckleshoot Canoe Captain Mike Edwards' report, as given at Alki Beach:

We had a nice event here today. We launched three canoes, and there were six canoes out on the water altogether to partake in the annual Seafair Pirates Day event at Alki.

We were approached early this year, asking if we'd like to participate with the Seafair Pirates on their special day. And so, we've been working with them since February, and everything turned out real nice today. This was the first time the canoes and the pirates did an event like this together. We look forward to possibly making it an annual event. We'll see how it goes.

## MAKING THE CASE FOR MUCKLESHOOT TREATY RIGHTS

*It might be a very different world today in Native America if not for Barbara Lane. The Boldt Decision changed everything. As the federal government's expert witness on behalf of the Tribe, her keen intellect, tough-mindedness, and thorough research may well have made the difference in what turned out to be one of history's greatest legal victories for treaty tribes. Now she is sharing her story with today's Muckleshoot people and future generations. This is must reading for all who want to know and understand the history of tribal sovereignty. It happened here. Please enjoy Part 1 of Barbara Lane's narrative:*

My name is Barbara Lane. I first visited the Muckleshoot Reservation in 1949. I have just recently enjoyed an exciting three day visit to the Reservation, having been invited to join in discussions about some projects the Tribe is currently pursuing. Between working sessions I was able to tour new buildings and learn about new programs that did not exist when I last visited the Reservation a few years ago.

On that prior visit I had been amazed and delighted to see the new buildings and the new programs that were already in place and operating successfully. I was impressed with the accomplishments of the Tribe in providing educational opportunities, taking over social services for the elderly and the very young, as well as planning economic ventures. There seemed to be a good balance between preservation of some aspects of traditional culture and providing for better educational and economic opportunities for present and future generations. However, that prior visit did not fully prepare me for the outstanding achievements of the last several years.

These new developments are testimony to the perseverance and vision of the present Muckleshoot Tribe – its administrators, members, and employees. Present accomplishments have deep roots going back through generations of Muckleshoot leaders – prominent persons and ordinary family members – who fought to preserve and protect traditional territory and resources, treaty rights, and traditional culture.

Based on a full reading of the contemporaneous record, it is clear that these earlier Muckleshoot people also sought to remain self-supporting and to live in peace with their neighbors. Recognition of the important role of these ancestors is reflected in the historic pictures adorning the walls of the public buildings and in the names bestowed on the buildings.

During the course of my recent visit, I was struck with the contrast of conditions on the Reservation today with those I had observed during my visit in 1949, a little over sixty years ago. We were walking from one building to another and I noticed that the pavement had a slight, but definite, tilt to it. I asked about it and was told that the tilt was built in so that rainwater hitting the paved path would flow into a catchment area and could be used as needed for watering grounds.

I remarked that in 1949 (and I don't know for how many years longer) there were neither paved paths nor a water system on the Reservation. Any water needed for household consumption had to be hand pumped from a communal well shared by a number of houses along the path. There was, of course, no indoor plumbing. Neither was there electricity available to the houses on the Reservation.

I had been surprised in 1949 because the neighboring town of Auburn had a water distribution system and electric lights. I had made an unwarranted assumption that if these were available in town, they would also be

available on the Muckleshoot Reservation. This led me to wonder whether younger Muckleshoot people today are aware of how different life was on the Reservation during the lifetimes of their great-grandparents, or perhaps even of their grandparents.

Similar questions cause me to think it might be useful to share some of my recollections of Muckleshoot people and events during the 1960s through the 1990s when I served as an anthropological expert witness in some Muckleshoot treaty rights cases.

I should make it clear that my earlier contacts at Muckleshoot were unrelated to any contemplated study related to Muckleshoot. I had entered the doctoral program in anthropology at the University of Washington in September 1948 and met Mr. Arthur C. Ballard on a number of occasions when he visited there. I was aware that Mr. Ballard had been doing ethnographic work with Muckleshoot people for decades. I have a high regard for the man and his work. It was only after his death that I began research on matters relating to Muckleshoot.

I take a moment here to explain how I came to visit the Reservation in 1949, because the people involved all made important contributions to the successes in later court cases. Robert B. Lane was a fellow graduate student in the Anthropology Department at the University of Washington. We married the following year, but at this time (1949) he was living in a rented room. His landlady was Miss Gladys McIlveen. She had been a social worker with the Bureau of Indian Affairs for many years.

"Mac" had made many friends at Muckleshoot and decided to visit them. She asked Bob to drive her to the Reservation and invited me to join the party. Bill and Annie Garrison hosted the party at their house. Annie's sister, Olive Hungary, and her husband John Hungary were there, as well as other people whose names I do not recall at present. These four were of great assistance to me in 1967 when I interviewed people at the Reservation in connection with the *State v. Robert Moses* case discussed below.

### 1968 – *State v. Robert Moses*

This was a test case, a "fish-in" pre-announced and approved by the Muckleshoot Indian Tribal Council, in which the four defendants – Robert Moses, Cecil Moses, Larry Maurice and Sherman Dominick – were charged with fishing contrary to State regulations. I was retained by the United States in April or May 1967 to research the treaty status of the Muckleshoot Indians, the creation of the Muckleshoot Indian Reservation, and genealogical history relative to the four defendants in the case. They asserted that they were Muckleshoot Indians, that they had treaty-protected rights to fish at usual and accustomed places, and that they were exempt from State regulation.

## GRADUATION 2012

### Another Measure of Tribal Progress

At a planning retreat almost 17 years ago the Tribal Council made the decision to develop the best education system in the region. We committed the resources necessary to control the Tribe's education destiny by investing heavily in Muckleshoot Department of Education Programs like the Early Childhood Education Center, Muckleshoot Child Development Center, Muckleshoot Tribal School, Education Support Services and Higher Education.

With another successful graduation season upon us it is an appropriate time to reflect on the great progress the Tribe has achieved since that early decision and recommit ourselves to the concept that education is a lifelong pursuit and the foundation upon which our future will be built.

Last month 16 high school seniors celebrated graduation at the Muckleshoot Tribal School. That brings the total number of Muckleshoot High School graduates to 54 since the new school opened its doors only three short years ago. This is a significant increase over graduation numbers we saw prior to opening our new school and reinforces the tribe's commitment to providing our students a culturally relevant environment and educational tools they need to achieve academic success.

As impressive as those numbers are they don't tell the full story. A total of 252 Tribal members celebrated graduation this year. From Head Start, Tribal Kindergarten, 5<sup>th</sup> Grade, 8<sup>th</sup> Grade, High School, college, post secondary certificates and GEDs, our community took full advantage of Muckleshoot educational offerings.

But graduation is more than numbers. It also represents a tremendous achievement for our students, their families and the entire Tribal community. It is an affirmation of the tribe's commitment to educational excellence and an important milestone in a lifelong journey toward achievement and success.

We are proud of all of our 2012 graduates and their families. We congratulate you on your achievement. We also want to acknowledge the dedication and hard work of the faculty and staff of the Muckleshoot Department of Education. Your commitment to educational excellence helps ensure that we will continue on the path toward a bright and prosperous future.

### Paddle to Squaxin 2012

In just a matter of days, on July 23, we'll be back here at Alki welcoming anywhere from 70 to 100 canoes. It'll be an all-day event, watching the canoes come in all afternoon. Canoes from the west and the north will be coming from Suquamish, and those coming from the north will be coming from Tulalip, with all the tribes will combining to come together here at Alki. Muckleshoot will be putting one canoe in at Suquamish and another at Tulalip.

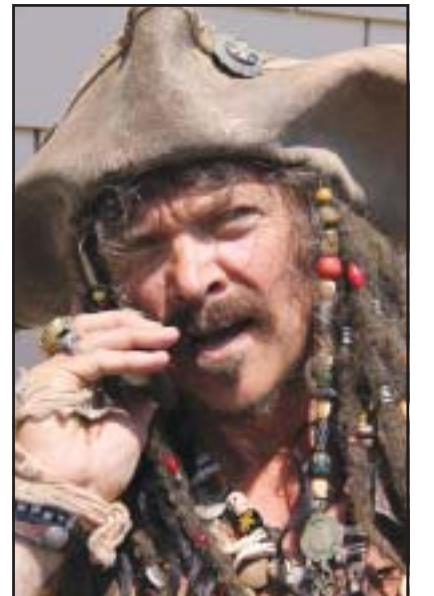
From here, we'll bring everybody home to host them at Muckleshoot for two nights before departing for Pullallup from Alki on morning of the 25<sup>th</sup>. On the 26<sup>th</sup> we leave to Nisqually for two days, and then on the 28<sup>th</sup> we head to Squaxin.

The 28<sup>th</sup> will like a "soft landing," where the canoes that want to participate will actually paddle out to Squaxin Island itself, where their

ancestors were raised, and spend the day there before coming back to the mainland to stay at Squaxin's new campground.

Sunday the 29<sup>th</sup> will be the formal protocol day, with all the canoes landing at the marina near downtown Olympia. Protocols will continue through the week at Squaxin. I'm looking at Muckleshoot taking the floor either late Friday or early Saturday. Squaxin will have the floor on Sunday, as will Quinalt, who will host next year. I figure late Friday night or early Saturday sometime for us. Or maybe late Saturday. We found out the Ahousahts requested the floor Saturday morning, so late Saturday night is a possibility.

We've been getting ready. We had a real good turnout today (at Alki) – enough for three canoes. The crew has been really gung ho about being out pulling this year. This is the most we've ever been out on the water before journey, so we're really looking forward to a good year, even though we have a limited amount of days on the water. We're looking forward to two big years for pulling following this year, when we'll paddle to Quinalt and Bella Bella.

Rita is currently enrolled at Antioch University and obtaining her Bachelor's degree in Liberal Arts with a focus in Native American Studies and Leadership Management. She is a certified NNAHRA as an HR Generalist, HIPPA, and CDA as a certified teacher.

This position requires confidential assistance to the Muckleshoot Tribal Members, community members and employees. Rita will act as a source of information and referrals, aid in answering questions, assist people in the resolution of concerns, assist in navigating organizational policies, procedures and processes.

She will act as an additional resource for issues and concerns to be brought forward and identify trends and recurring issues for managerial responsive actions. She

will record and compile community issues in a manner to analyze for further investigation, development of solutions for organizational improvement.

Rita would like to encourage all community members to see her for any concerns and is she excited to be able to act on your behalf as a liaison for individuals and group needs. ## LEAVING YOUR LEGACY

Drafting a will is much more than simply leaving your personal property to family members. A will provides a sense of security for your family who will be able to avoid the lengthy and potentially messy probate process which accompanies an individual who passes intestate (without a will). Ensuring that what you've worked your whole life to acquire is passed on to an individual who will appreciate it as much as you do is an important aspect when thinking about planning your estate.

Also, with the introduction of the American Indian Probate Reform Act, planning your estate is imperative if you have a non-tribal partner/spouse/child because there is the potential of losing your trust land if it is not

devised properly in your will. Without a will the legacy that you leave will be decided by the law. It is your land and personal property and it should be devised according to your wishes.

If you're interested in having your will drafted or have questions regarding your estate, the Institute for Indian Estate Planning and Probate at Seattle University School of Law has an intern, James Henry, working in the Philip Starr Building. Mr. Henry will be available until July 24<sup>th</sup> and can be contacted at (253) 876-3321 or james.henry@muckleshoot.nsn.us. This service is free to all American Indians within a 30-mile radius of the Tribal Administration building.



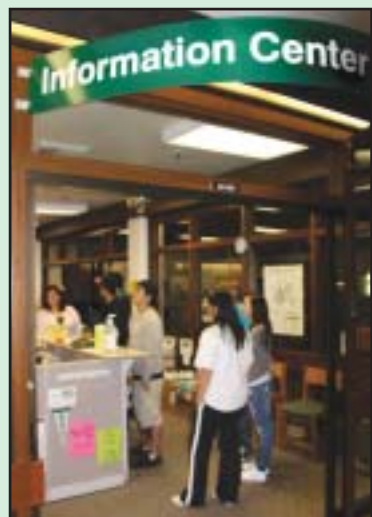

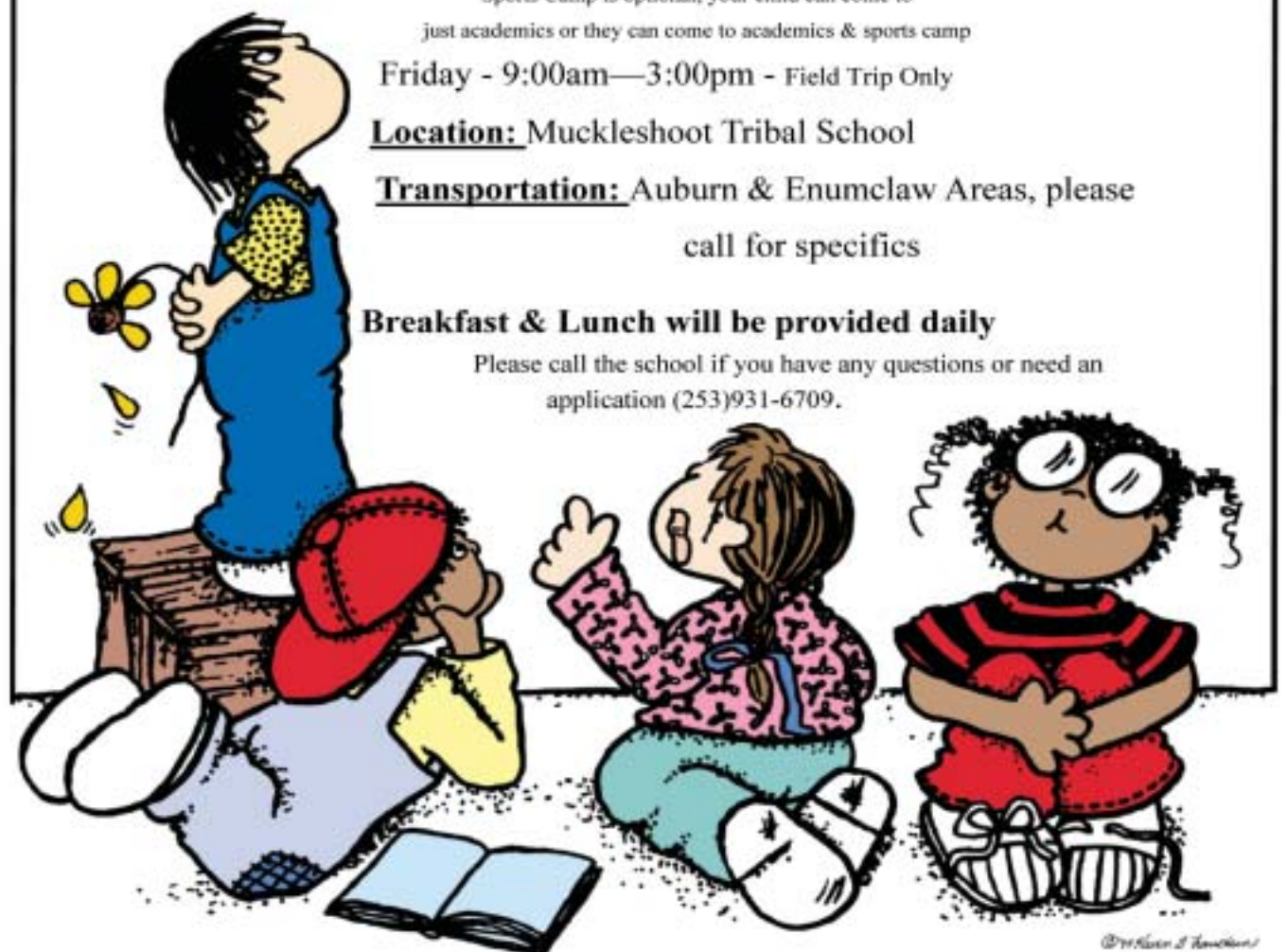

Suboxone (Sub-ox-own) referrals and treatment now available @ HWC!

Help for prescription pain medication dependence is now being offered through the Health and Wellness Center. Suboxone is also used in the treatment of other opiate-based or synthetic opiate drug dependence. These drugs include: Oxycodone/Oxycontin, Hydrocodone, Vicodin, Heroin, and Morphine.

SUBOXONE is the first opioid medication approved under Drug Addiction Treatment Act (DATA) 2000 for the treatment of opioid dependence in an office-based setting. The primary active ingredient in SUBOXONE is buprenorphine.

SUBOXONE at the appropriate dose can:

- Reduce illicit opioid use
- Help patients stay in treatment
- Suppress symptoms of withdrawal
- Decrease cravings for opioids

The Health and Wellness Center has a medical provider licensed to prescribe suboxone.

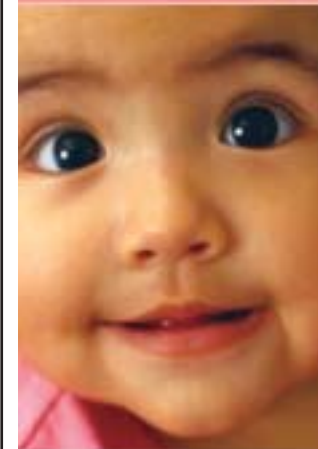

### Protect your baby from whooping cough. GET YOUR PERTUSSIS VACCINATION.



#### What is Whooping Cough?

Whooping cough causes coughing that makes it hard for a child to eat, drink, or breathe. Babies younger than 6 months who get whooping cough often must be hospitalized. It can also lead to pneumonia, seizures, and other complications.

#### How Does Whooping Cough Spread?

Whooping cough spreads easily by coughing or sneezing. Babies usually get it from parents, grandparents, brothers, or sisters who may only have a mild cough and not know they have whooping cough.

#### How Can I Protect my Baby?

Older children, teens, and adults can help protect themselves and babies around them from whooping cough by getting a Tdap (tetanus, diphtheria, acellular pertussis) booster.

#### How Do I know if I Need a Tdap Booster?

Call the Medical Clinic at 253-939-6648 and we will help you determine if you need a Tdap booster to ensure your whole family is protected against whooping cough.

#### Can I get a Tdap Booster if I'm Pregnant?

YES!!! As long as you are over 20 weeks pregnant, you may get a Tdap booster if you haven't already received one. Call the medical clinic and we can help you determine if you need the booster. EVERYONE who will be living with the baby or have close contact with he/she when they come home will need to call the Medical Clinic at 253-939-6648 to determine if they need a Tdap booster.

**CONTRACT HEALTH SERVICE (CHS) NOTIFICATION REQUIREMENTS**

## CHS OFFICE (253) 939-6648

1. Notify CHS office before any non-emergent services are rendered to determine patient eligibility, medical priority and to set aside funds for payment. Pre-authorization is mandatory and failure to comply is reason for denial of payment for claim(s).
2. In true medical emergencies, notify the CHS office within seventy two (72) hours of start of services. Failure to comply is reason for denial of payment of claim(s).
3. Prior notification does not guarantee CHS can pay for services, unless all other CHS requirements are met. There are some services CHS can not cover.

**ALTERNATE RESOURCE REQUIREMENTS:**

Muckleshoot CHS is a residual resource and not an entitlement program. In addition to CHS, other resources for health care are available from various state, and federal programs, as well as individual and group health insurance policies. By federal law, CHS must ensure that all resources, where and when applicable, are utilized before CHS can assume financial responsibility for your care.

This means that CHS will not be authorized if you are eligible or would be eligible upon making an application for an alternate resource such as: Medicare (over age 65 or disabled at any age), Medicaid (medical coupons), crippled children or have private insurance etc. Failure to comply with a CHS office referral to an alternate resource will terminate your CHS coverage. You are required to use these benefits as your first source of payment of your medical-related costs.

The CHS office is required, as per IHS Federal Rules and Regulations, which requires all CHS denials to patients be sent by certified mail to the address on file.

## “Your Suggestions Count”

The Muckleshoot Health & Wellness Center offers “suggestion boxes” where guests can fill out forms to share thoughts, comments or suggestions. The purpose of these forms is to help us improve the quality of services offered to the community. These forms are not “incident reports”, but rather confidential and private opportunities to share your thoughts on what we are doing well or on ways we might improve.

The suggestion boxes are located in each reception area and the main lobby of the building. The feedback forms are located next to the boxes. The boxes are checked at least twice a month by the Facilities Secretary and then delivered directly and confidentially to the appropriate department manager. After several months of searching through official records of the federal government, I was able to find sufficient proof to convince Judge Shorett of the State Superior Court that Governor Stevens (Isaac Stevens, first governor of Washington Territory) reported to his superiors that he had treated with the Indians in the Green River-White River region.

These Indians, who later became known as the Muckleshoot Indians, were noted in the preamble of the Treaty of Point Elliott as local bands deemed to be signed for by Chief Seattle. The knowledge of the linkages in kinship relations provided by Annie Garrison and Olive Hungary made it possible to trace the lineages of each of the defendants to Green River-White River ancestors.

The knowledge and expertise of Louis Starr, Bill Garrison, and John Hungary provided detailed information about fisheries in the Green River-White River region. I was able to check the information gained in these interviews with an unpublished manuscript by anthropologist Dr. T.T. Waterman. The information had been collected by Professor Waterman as he travelled by canoe along the river system, accompanied by a knowledgeable Indian informant some 47 years earlier.

Waterman recorded the place names, including village sites and fishing places. The manuscript had not been seen by any anthropologist working in western Washington prior to the use of this material as an exhibit in the present case. The existence of the manuscript was brought to the attention of Dr. Wayne Suttles, who had not been able to get to the Smithsonian Institution in Washington, D.C. to examine it. Dr. Suttles alerted me to the existence of the manuscript, realizing it might be vital evidence to assist the Muckleshoot and neighboring tribes in western Washington.

The Tribe's role in bringing this test case and providing detailed and substantial proof of the necessary facts was a major breakthrough in a long string of treaty fishing rights cases in western Washington.

The State court system was not the place to determine federal treaty rights. That issue was addressed several years after *State v. Robert Moses* when the United States filed *U.S. v. Washington*, also known as the Boldt case.

ily grew by two – daughter Amiah and husband T.J. Pedro. She became a college graduate, and finally MIT Human Resources Director.

To succeed over such a long period of time in the HR field, you have to have a good way with people, and this comes naturally to Anita.

"I think it comes from the way I was raised," she says. "I was around a lot of people in the tribe. I spent time with different families. It's just how we grow up in the tribe. I remember staying the night with a lot of different people, and I think that helped me with communication, and adapting and paying attention to how people are reacting – body language, whether they're "buying what I'm saying" kind of thing, or understanding me."

"I'm good at making people feel comfortable, and I see that in Human Resources. You have to be able to do that. You have to be able to speak to a manager one minute and then speak to a tribal member and understand all the different levels of concern and make sense of it."


In addition to everything else she's done, and in common with so many others, Anita has also taken the time to serve her tribe on some of its many committees, including Housing, Veterans (in honor of her grandfather, "Pun" Courville), and the Indian Preference Committee – a cause she believes in very strongly. She has twice been elected to the Muckleshoot School Board, serving for four years as its chair.

"I think my family has always been active in the tribe," she says, noting that some do so publicly, such as her aunt Rita Martin and uncle Virgil Spencer, while others prefer to do their work for the tribe behind the scenes in different ways.

"We all value the tribe," she says, "and we all do our part in whatever we think is contributing to its betterment."

The Muckleshoot Tribe has always been known for its strong women, and Anita Pedro is certainly one of them. Human Resources is a tough profession, and serving as the tribe's director will inevitably bring many challenges, but we now have someone in the position who is home-grown, extremely well trained, and who knows how to do things in a good way.

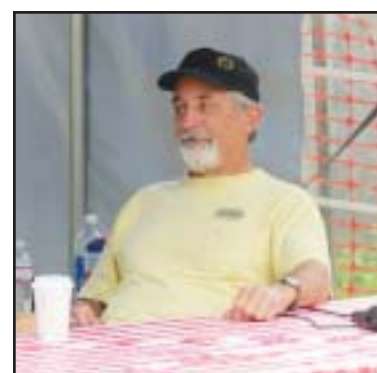

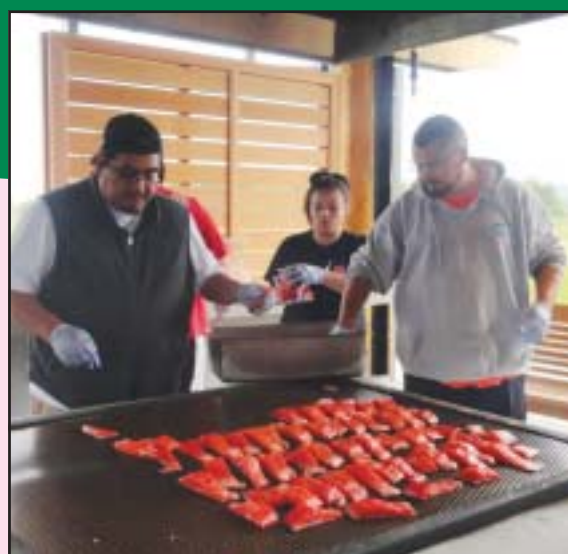

### A Couple of Happy Memories With Doug

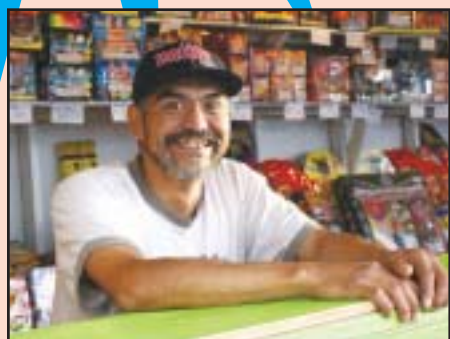
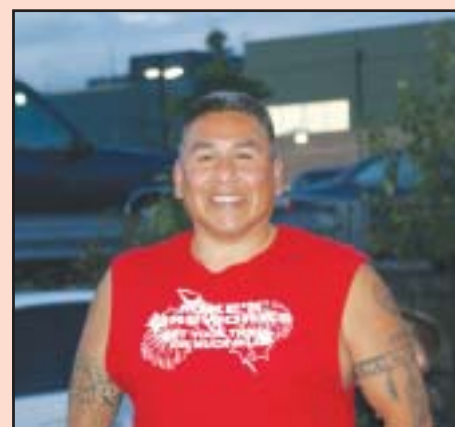

### Important Dates/Registration Cutoffs for 2012 WA State Elections

#### Primary Election

July 18: Ballots for the Primary Election are mailed.

July 30: Last day for people who are not currently registered in Washington to register in person at the Auditor's Office.

August 7: Primary Election Day

#### General Election

October 8: Last day for people to register by mail or registration drive.

October 8: Last day for people to update their address.

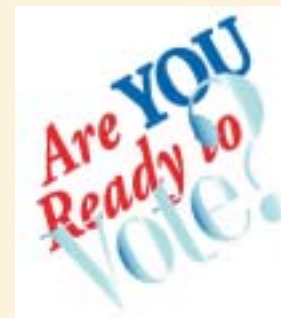
October 17: Ballots for the General Election are mailed.

October 29: Last day for people who are not currently registered in Washington to register in person at the Auditor's Office.

November 6: General Election Day

People may register to vote or change their address after these cutoffs; however, registrations and/or changes to registrations will not go into effect for the given election.

### Voter Eligibility Requirements



To register to vote in the state of Washington an individual must:

- Be at least 18 years old by Election Day
- Be living at the address for at least 30 days prior to Election Day.
- Be a citizen of the United States.
- Not presently be under the authority of the Department of Corrections.

#### Voters must also:

- Provide a VALID residential address. This address must be within Washington State, and must be their place of residence. Residence is defined as "a person's permanent address where he or she physically resides and maintains his or her abode" (RCW 29A.04.151). Persons without a traditional address shall be registered to vote and assigned a precinct based on the location provided. Exceptions are made for military personnel, individuals engaged in navigation, and students.
- Provide a valid Washington State issued ID or WA Driver's License, OR the last four digits of their social security number. Additional provisions are made for individuals who do not have either of these items. They may complete the form, submit it, and we will contact them directly.

### Completing The Voter Registration Form: Required Fields

Please follow the instructions on the Washington State Voter Registration Form

The following fields MUST be completed for the form to be valid:

Citizenship and Age - the VOTER must affirmatively answer these questions.

WA ID or Driver's License

Birthdate

Name - the voter's name MUST be written EXACTLY as it appears on his or her ID or driver's license.

Residential Address - This must be the physical address where the voter resides.

Businesses and PO Boxes are not acceptable as residential addresses.

Signature - No form is valid without a signature after the voter declaration.

If the voter is currently registered in Washington at a different address, or under a different name, have them complete the section titled former registration.

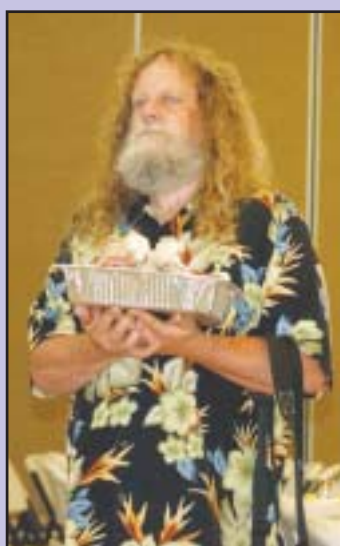



### PER CAPITA REMINDERS

- When you turn 13 or 18 during a Per Cap Distribution and you have Direct Deposit you will need to turn in a New Direct Deposit form for your new Age group otherwise we will cancel your Direct Deposit until we receive a new one. Teen Direct Deposit Form (orange) Adult Direct Deposit Form (brown) or Seniors (green)
- If you want someone else to pick up your Per capita Check you need to fill out an Authorization Form and have it notarized and turn it into Tax fund. We will not accept forms that are not notarized.
- If you have closed your Bank Account please notify Tax Fund As Soon As Possible so that we can cancel your Direct Deposit. If you wait and we have already send in your Deposit to the Bank you will have to wait until the Bank sends a letter to Tax Fund stating that the deposit did not go through (this can take 1-5 days), then we have to print you a check. This will delay you getting your money in a timely manner.
- If you or a family member are incarcerated and want to notify Tax Fund of what you would like us to do with your Per Cap (mail, put in someone else's name, hold it or just want someone to pick it up) We require a letter to be mailed to Tax Fund directly from the jail so it is unopened when we receive it. This is the only way Tax Fund will follow the request being made from an incarcerated Tribal Member
- Things to double check before Per Cap Distribution to make sure Tax Fund and Enrollment has your correct information:
  - Address Change has been updated
  - Your name has changed and you have a Social Security Card showing your new name. Enrollment will need a copy of this before Tax Fund can change in their system.

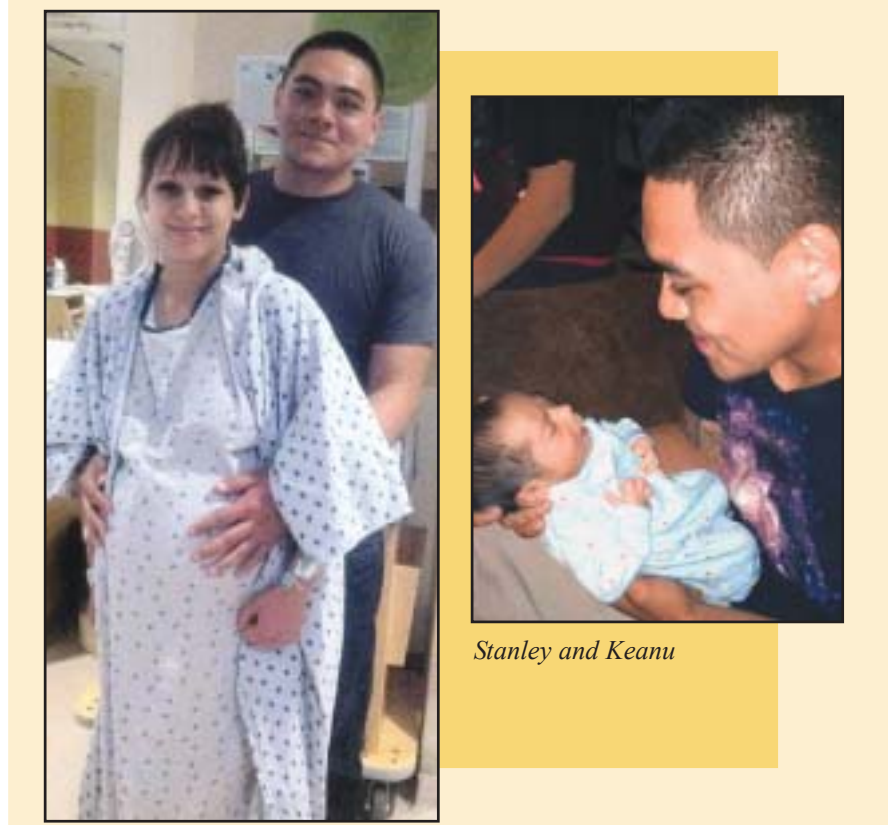

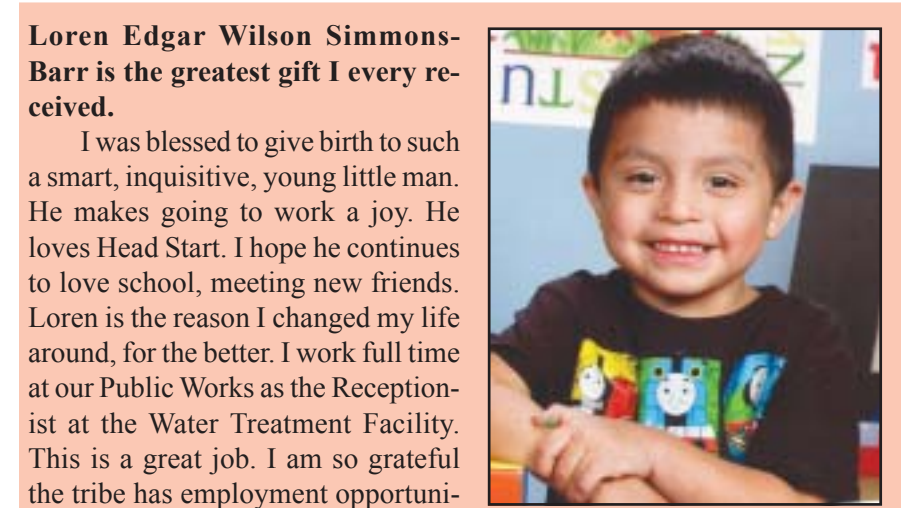
