### Election to be held January 21

The annual Public Caucus was held on October 16, 2018. Fifteen (15) candidates were nominated for the three positions on the Tribal Council that are up for election this year. Incumbents John Daniels Jr., Jaison Elkins and Mike Jerry Sr. will each be seeking re-election to another three-year term.

Tribal Council elections are held annually, with three of the nine members up for election each year. Please note that this newspaper went to press before the deadline for candidates to withdraw their name from consideration.

## New Seattle School Superintendent Denise Juneau Visits Tribe

On Monday, September 17, Denise Juneau, the Seattle School District's first Native American Superintendent, was the honored guest of the Muckleshoot Tribe. Education has always been a top priority for the tribe, and the Tribal Council pulled out all the stops to showcase its impressive array of educational programs.

After an invocation and song was offered by Tribal Elder Donna Starr, Tribal Council Chair Virginia Cross offered a formal welcome to Superintendent Juneau, who responded graciously in kind. The Muckleshoot Tribal School Song and Dance Group, under the direction of Teresa Allen, presented a fine program of Muckleshoot singing and dance.

Tribal Education Officer Joseph Martin then gave an overview of MIT's Education Division, after which he turned the floor over to those who oversee the various programs, each of whom gave excellent and informative presentations.

An enrolled member of the Mandan Hidatsa Tribes, as well as being a Blackfeet, Tlingit and Haida descendent, Denise Juneau has become a historic

figure in Indian Country. Her life story takes her from Head Start to Harvard. After graduating from Browning High School, she received her bachelor's degree from Montana State University and went on to earn a Master's in Education from Harvard University.

After teaching and working at the state education agency for several years, Denise set her sights on the legal profession, earning Juris Doctorate from the University of Montana School of

Law.

In 2008, she became the first American Indian woman in the country ever elected to an executive statewide office when she was elected at Montana's Superintendent of Public Instruction. She served in that capacity for eight years and in 2016, with the strong support of the Muckleshoot Tribe, ran for Congress as a Democrat, falling short in a challenge to US Rep. Ryan Zinke, who has since become Secretary of the Interior.

After an extensive nationwide search, Denise was then hired as Superintendent of Seattle Public Schools, and is now in her first few months on the job.

Superintendent Juneau's first visit to Muckleshoot was a memorable occasion. After the MIT Education presentations concluded, she was wrapped in a blanket and everyone enjoyed visiting and posing for pictures with her. We look forward to her next visit!

My father is Dr. Willard Bill, Sr., my father's father is Lyman Willard Bill, my father's mother is Iola Bill-Lobehan. My Great Grandmothers are Clara Siddle and Annie Jack Daniels. These Muckleshoot ladies were the two most significant women in my father's childhood – his first teachers. My mother is Mary-Ann Bill.

My purpose for living is my children, Elise Bill-Gerrish, and, Andrew Gerrish. The bright hope of my life is, Miss Lily Hope Davis, my baby grand-daughter.

Dear Highline College Staff, Students, Muckleshoot Tribal members & all other Tribes and Indigenous people here today, on October 8, 2018, Indigenous Peoples Day.

Today I am going to talk about the facts about Indigenous Peoples Day. Facts are important, even, if some of our society, notably some politicians, and, their supporters, do not think they are important.

Once upon a time we only had non-Indigenous people writing history books for our children. Our children grew up, and, many still do, reading un-truths, or half-truths about Indigenous history.

You already know one of the most egregious errors. The

egregious error I am talking about is a person called Christopher Columbus. When I was teaching for Northwest Indian College a few years ago, we spent class time studying the true facts. The true facts are not for the faint-hearted. It is almost unbearable to discuss.

School Districts across the country for over sixty years had textbooks telling children Columbus discovered the United States of America. This, as you know, is not true. If you want to learn about the facts of Colum-

bus you could read books, read dissertations by Dr. Sabis-Burns who has done work in the area of Columbus and children's books, watch you-tube clips, and look to your local Native Tribes to share with you the truth.

For today's discussion, let's go over a few facts about Columbus, and then we will move on to the focus of Indigenous Day 2018:

- Columbus invaded the Caribbean with a Spanish Armada, and was person-

ally responsible for almost bringing the Taino people to extinction.

- Columbus referred to the Taino people as savages.
- Columbus and his armada, kidnapped thousands into slavery and he and his shipmates raped and pillaged the Taino people.
- The Holocaust of Columbus alone killed four million people in San Salvador in four years.

Just as the Taino people suf-

**Ballot Box location:** The nearest King County ballot box is located right out front of the Philip Starr building. (Do not confuse it with the blue Muckleshoot ballot drop box by the front door.) King County ballot boxes are currently open 24/7 and will close on **Election Day, November 6th at 8pm.**

### Ballot Measures

**I-940, Police Use of Force (De-Escalate Washington)** - Initiative 940 would create a good faith test to determine when the use of deadly force by police is justifiable, require police to receive de-escalation and mental health training, and provide that police have a duty to render first aid. It would remove the requirement that prosecutors show that a law enforcement officer acted with malice to be convicted. The Washington State Supreme Court recently ruled that the initiative, but not the "clean-up bill," HB 3003, passed by the Legislature during the 2018 session, will go to the ballot. Indications are that all stakeholders have agreed to pass the language contained in HB 3003 during the 2019 session, regardless of what happens with the initiative in November.

**\*\*I-1631, Carbon Fee** - The initiative would enact a carbon emissions fee on large emitters. The fee would be \$15 per metric ton of carbon beginning on January 1, 2020, and would increase by \$2 per metric ton each year until the state's greenhouse gas reduction goals of 2035 are met and the 2050 goals were on track to be met. Revenue from the fee would go into three funds: (1) a fund for air quality and energy programs and projects, (2) a fund for water quality and forest health projects, and (3) a fund for investments related to communities. Proponents argue that under Washington State law, this measure is a fee and not a tax because the revenue cannot be spent on government expenses or public program, but rather is dedicated to specific accounts related to investing in climate and environmental projects.

**I-1634, Grocery Tax Prohibition** - This measure would prohibit local government entities from imposing any new tax, fee, or other assessment on grocery items. It would not prevent the state from imposing taxes on groceries. Grocery items are defined in this measure as "any raw or processed food or beverage, or any ingredient thereof, intended for human consumption." Groceries include but are not limited to meat, produce, grains, dairy, seasonings, and condiments. Alcoholic beverages, tobacco, and marijuana products do not qualify as grocery items and would not be protected from new taxes by this measure. The measure would prohibit any existing taxes, fees, or assessments from being increased after January 15, 2018.

**I-1639, Firearms Regulation** - This measure would implement restrictions on the purchase and ownership of firearms. It would boost the legal age to buy a semi-automatic rifle from 18 to 21. Those who want such a weapon would have to pass an enhanced background check, take a firearms-training course, and wait 10 business days after purchase to take possession of the gun. The initiative also requires owners to keep their guns secured at home, or they would face misdemeanor or felony charges, in some cases, if someone prohibited from possessing a weapon got access to it. According to the initiative, a semiautomatic assault rifle would be defined as: "any rifle which utilizes a portion of the energy of a firing cartridge to extract the fired cartridge case and chamber the next round, and which requires a separate pull of the trigger to fire each cartridge. Semiautomatic assault rifle does not include antique firearms, any firearm that has been made permanently inoperable, or any firearm that is manually operated by bolt, pump, lever, or slide action."



## Wildlife Program Participates in Olympic National Park Goat Translocation

Many of you have heard that mountain goats are being removed from Olympic National Park (ONP) and are being transported to the Cascades. The effort is being done to reduce resource damage by non-native goats in ONP that have ballooned to over 700 goats. The removal and translocation will benefit native goat populations in the Cascades that have been reduced dramatically below their historical numbers.

Four translocation periods of 2 weeks each are planned to remove and transport as many goats as possible, likely at least 350, with the remaining goats scheduled to be killed. The Park Service goal is to remove all mountain goats to avoid future problems. The Washington Department of Fish and Wildlife (WDFW) is taking the lead for the translocation.



Goats will be released at 12 sites in the Cascades. Only one is south of I-90. Goat Mountain, which borders the Cedar-Green River was chosen as the best release site south of I-90 due to restricted public access and current use by native goats. Corral Pass and Kelly Butte would be good areas, but there's too much public access that might result in too many human-related goat mortalities. Furthermore, translocated goats might disperse to those areas anyway.

Muckleshoot contributed funds toward the 2018 goat translocation by purchasing collars to put on goats brought to the area south of I-90. A total of 19 goats were released at Goat Mountain in the Cedar River on September 11 and 14 – 11 females and 8 males. One yearling male did not have a collar due to potential neck size expansion, and one female kid has an expandable drop-off collar. The remaining 17 adults are wearing tracking collars.

new surroundings. The attached map shows some rough movements between the release site and where goats were only three weeks later. Because we also received six transplants goats from Oregon in 2016, we do not expect to receive goats in 2019, but maybe in 2020 depending on availability, mortalities, and need.

As expected, some goats moved rapidly in various directions from the release site, and oddly a couple came back after checking out their

In other areas of the Cascades north of I-90, 79 goats were released at four sites. Some of those goats also have made exploratory movements far from the release site. Collars for these goats were provided by WDFW, ONP, Stillaguamish and Sauk-Suiattle Tribes, and the Rocky Mountain Goat Alliance.

The Wildlife Program conducted a goat survey in 2009 north of I-90 to the south fork of the Stillaguamish River. Goats in this area had been historically surveyed

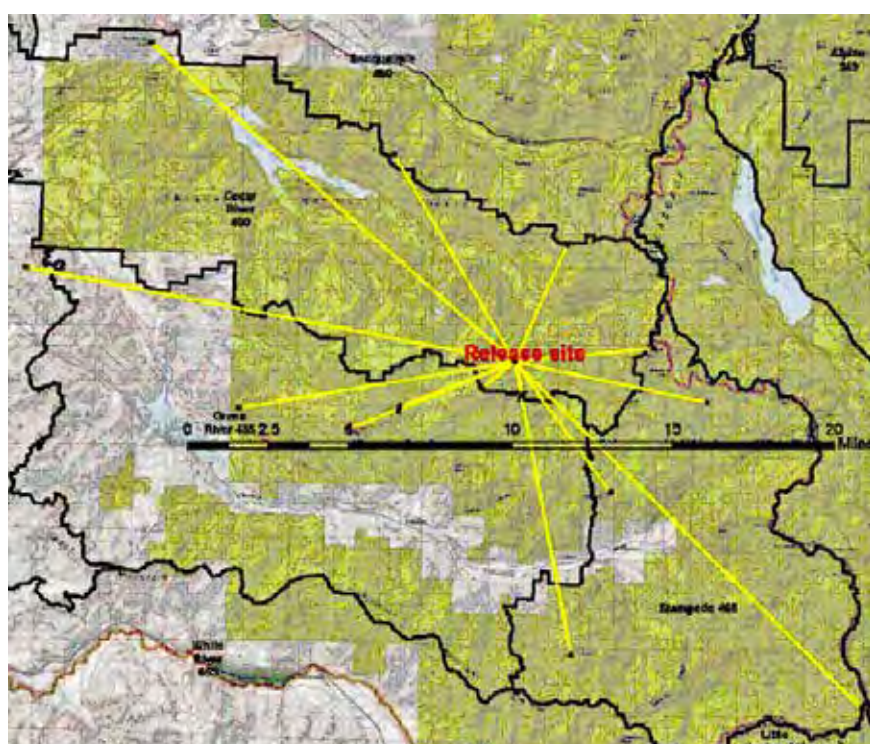
by WDFW up until 1997 when they quit surveying because hunts were stopped in the area. WDFW protocol is to survey goats only in areas where there are hunts. Only 50 goats were seen by the WDFW in 1997.

In 2009 we saw 92 goats in roughly the same area. Our survey helped identify the need for translocating goats into areas north of I-90 due to large areas of unoccupied habitat. Funding for the MIT goat survey came from the BIA, US Forest Service, and the Wildlife Program.

Muckleshoot has surveyed mountain goats south of I-90 to Mount Rainier NP since 2003. The number of goats observed varies due to conditions, but the total seen has been consistently below 60 animals – too few to open a hunt in Game Management Units 460 south of I-90, 466, 485, 490, or 653. The additional 25 transplant goats should help the resident goats remain stable, or possibly increase slightly. It will take a long time for goats to increase to a point where a very limited permit-only hunt might occur.

In 2016, we assisted the WDFW with translocating six goats from Oregon to Goat Mountain. Four of those goats are carrying radio collars and are alive. Those goats are currently at Tinkham Peak, Meadow Pass, Rooster Comb, and Quartz Mountain on the east side. Two of those goats had ear transmitters that pulled out (1) and battery expired (1), but both were seen together in May 2018 in the North Fork of the Green River. We recently saw kids with 2 of the transplant goats so we know they have interacted with native goats and are contributing to local goat populations.

## THE FOUNDING OF THE AMERICAN INDIAN MOVEMENT

That's Dennis Banks, with the tie and clipboard, and Clyde Bellecourt next to him with glasses. Martin Luther King had been assassinated just three months before, and Robert F. Kennedy the previous month. Wishelle Banks shares her uncle's written recollection of that midsummer night in Minneapolis:

"Our first meeting was set for eight o'clock on the evening of July 28, 1968, in the basement of a run-down church. In those days, about forty or fifty people would come to any given Indian meeting... I went out and bought a hundred plastic cups, some Kool-Aid, coffee, and fifty donuts. We borrowed some chairs and hurried to the church to

prepare for the meeting.

I wrote on a scrap of paper the kinds of issues I thought we should discuss – prisons, courts, police, treaties, the government. By six o'clock, already ten or fifteen people – besides the ten who had been helping to organize the meeting – had shown up. Between six-thirty and seven, about 50 more people arrived. Before long the donuts were gone. By eight o'clock, the place was packed. Almost 200 people had gathered to listen, and to begin making their voices heard..." ~ Dennis J. Banks

...and the rest is history.

# MIC TDP Hosts 4th Annual Round Table Conference

Muckleshoot Casino strongly believes in giving back by helping tribes succeed in career advancement. In that spirit, the Tribal Development Program (TDP) hosted its fourth annual RoundTable Conference and Expo at Emerald Downs in Auburn, Washington on September 18-19, 2018.

**Building for Tomorrow**  
A free event, the RoundTable Conference and Expo would be invaluable for any casino or tribe looking to implement a Tribal Development Program (TDP) for members. Last year's event was a huge success. Approximately 50 people from tribes across the country attended. Participants were given a thumb drive with a



copy of program documents (job descriptions, learning plans, and smart goal templates) that could be customized to their needs. Sharing of info. We have traveled to other properties to help evolve or develop their program. This also helps us evolve our own program.

Muckleshoot Casino's RoundTable isn't just panel discussions! We gave attendees break-out sessions to have more time to share what works and what doesn't work when implementing a program, we hope

to help prevent or overcome stumbling blocks and growing pains. We had a Tribal Council (past and present) Panel, Pre-Apprentice and Externs participant panel. Guest Speakers. Giveaways have included native art pieces by Gail WhiteEagle, cultural gift baskets and more.

For tribes that don't have a program in place, that's OK! We can help you hit the ground running by providing program documents and a wealth of personal experience.

This year, we kept the evening of Tuesday, September 18, 2018 open for a networking dinner at the casino and a tour of our Tribal Development and Talent Development offices.

**A Record of Achievement**  
Over the years, Muckleshoot Casino's Tribal Development Program has had countless success stories.



Below are some new programs:  
Pre-Apprenticeship program through Bates Technical College. A new 11 week program to prepare Muckleshoot Tribal members, for

the construction and carpentry work force. They completed building a brand new shed from start to finish.

Course includes exposure to other trades, and preparation for apprenticeship programs, and will cover introductory instruction in basic safety, construction math, hand tools, power tools, construction drawings, financial literacy, basic communication, employability skills, and material handling.

Upon completion students will have 4 certificates in forklift, WA state traffic control flagger, industrial first aide, and construction safety OSHA 10.

We had two participants graduate this program. One has moved onto HVAC technician and the other has moved into Building Maintenance Engineer.

The Externship program was established to create a collaborative and innovative relationship across properties and other entities. The purpose is that through this exchange, it would provide additional off-site training, and an opportunity

to gain valuable applied experience and make connections in a professional field that may be in consideration for a career path. The Externs length of placement varies and is structured individually.

We had two participants in the program. One was placed at the Salish Lodge for a 15-week rotation throughout operations that included sales, spa, gift shop, reservations,



front desk, hotel operations, etc. This participant successfully graduated their externship with Salish and is looking into a possible 2nd phase extern with the Four Seasons in Seattle. The second extern is placed for approximately 18 months at the Tribe with Development Services in the Construction

Department.

**Investment Yields Success**  
Muckleshoot Casino's original Tribal Development Program was approved in 2004, and fully funded by Council resolution in 2006. This is an ever-evolving program and has had several revisions.

We believe in helping our participants succeed by giving professional and personal development time during working hours for school studies and providing soft



skills training on a monthly basis. Quarterly team-building exercises that incorporate learning with fun events such as softball and Laser Tag alongside designated trainers and managers are also conducted.

Twenty three years ago, Muckleshoot Casino's Table Games department had one tribal member in management. Now, we have 11 tribal managers and two non-tribal managers. That's a 900% increase!

Participants are not obligated to stay with the casino. Some have taken the skills learned here and applied them to jobs elsewhere. Many have transitioned to positions within the Muckleshoot tribal government as well as other businesses. We even had one participant who moved to another tribe and is



now heading up the I.T. Department.

Two of our TDP participants have gone on to serve on Tribal Council, one executive director in Tribal Gaming Agency. One participant has moved to Assistant Director of Muckleshoot Tribal Government.

We also have five Business Leaders, one Executive director in Support Ops within the casino. We encourage others to reach high and work hard to achieve their own success.

We are looking forward to next year's Roundtable in Arizona were Casino Del Sol has graciously offered to host the fifth annual.

ferred so terribly in their Holocaust, so did other Indigenous people all over the world, and in the U.S. where we are today. Other cultures, like the Jewish cultures, have produced films like *Schindler's List*, *Diary of Anne Frank*, *The Pianist* and others, to correct history and to make sure the Holocaust never happens again.

In Washington State, two house bills were developed to correct Native History in K-12 School Districts. Mr. Denny Hurtado, Director of Indian Education for Washington State, in the early 2000's, led five Think Tanks to develop the proposal calling for School Districts to teach about Washington State Native Tribes in schools. Mr. Hurtado established five Think tanks: 1) Native American, 2) African American, 3) Asia-Pacific Islander, 4) Latino, and, 5) Low Socio-Economic.

In 2004, HB 1495 was passed to recommend Washington State School Districts to teach about Native Tribes in Washington State. House Bill 5433 passed in 2015. HB 5433 is an amendment to HB 1495. Senator John McCoy, a Tulalip Tribal member, led the initiative for both HB's, with the help of the 29 tribes in WA State and the State's Office of Native Education. HB 5433 mandates the teaching of tribal sovereignty curriculum at the elementary, middle and high school grade levels. The changes mandated by HB 1495 and HB 5433 are one way of correcting history.

Today, there are four states – Minnesota, Vermont, Alaska, and South Dakota – and over 60 cities celebrating Indigenous Peoples Day, including Los Angeles City and County; Berkeley, CA; Santa Cruz, CA; San Fernando, CA; Watsonville, CA; Seattle (2014); Olympia, WA; Spokane, WA; Bainbridge



Island, WA; Minneapolis and Grand Rapids, Minnesota; Denver, Durango and Boulder, CO; Phoenix;

Ann Arbor, Traverse City, East Lansing and Ypsilanti, MI, Albuquerque and Sante Fe, NM; Portland and Eugene, OR; Newstead, Lewiston and Ithaca, NY; Anadarko, Norman and Tahlequah, OK, Carrboro and Asheville, NC, Belfast, Bangor, Orono, Brunswick and Portland, ME, Bexar County, TX; Cambridge, Amherst and Northampton, MA; Harpers Ferry, WV; Lawrence, KS; Davenport, IA, Durham, NH, Moscow and Oberlin, OH; Salt Lake City, UT; Austin, TX; Nashville, TN and Madison, WI.

Efforts are also being made in WA State School Districts. Last year, under Ms. Sui-Lan's leadership, Enumclaw S.D. voted for Indigenous Peoples Day. In 2014 Seattle School District adopted Indigenous Peoples Day. Other school districts have followed: Kent, Marysville, Edmonds, Spokane, and others.

Today, along with my relations from the Muckleshoot Indian Tribe, I would like to share some other ways we as a people are correcting history. First of all, as much as we all love casinos, we are more than casinos. Most Native Tribes who own casinos invest most of their family money into services for their people. For example, Muckleshoot invests our family money (otherwise known as profits) into housing, education, health care, Social Services, Behavior Health Services & Recovery Services, Fisheries, Forestry (in 2013 MIT purchased 96,307 acres of forest land), Public Works, Youth Programs, the Muckleshoot Child Development Learning Center, and much more.

The Muckleshoot Indian Tribe has two treaties we are connected to: 1) The Treaty of Medicine Creek; and, 2) Treat of Point Elliott. The time frame is 1855/56.

The Muckleshoot Tribal College is a partner-based program with approximately 200 students, or more served over a one-year period of time. The MTC has been recently working on a research initiative under the great mentorship of one of our revered elders, Mr. Gilbert King George.

Mr. King George, known as "Hoagie," and his wife Tallis, give generously of their time to move us forward in becoming a Research Institute. Hoagie always starts our meetings out in a cultural way, with the words: "Be Kind, Be Helpful, Be Sharing."

Our vision statement is: "To become a unique research institution that serves as a repository and resource to: Be a medicine to Our People, Bring a Healing to Our Community, and Restore the Strength of Our People."

As I close my comments for today, I would like to mention that we Indigenous people are a strong people. On Saturday, after the announcement was made about the next Supreme Court Justice, I made a Facebook post that said:

"Native people are not new to bad decisions by the U.S. Government. Native people are not new to men who hurt our women and children. A person named Columbus did not win. He did not stomp out the Taino Indigenous people, and other innocent men, women, and, children. We know what to do: We survive, we live, we heal, we stand together. We move forward. We honor our ancestors by living. We choose kindness. We choose respect."

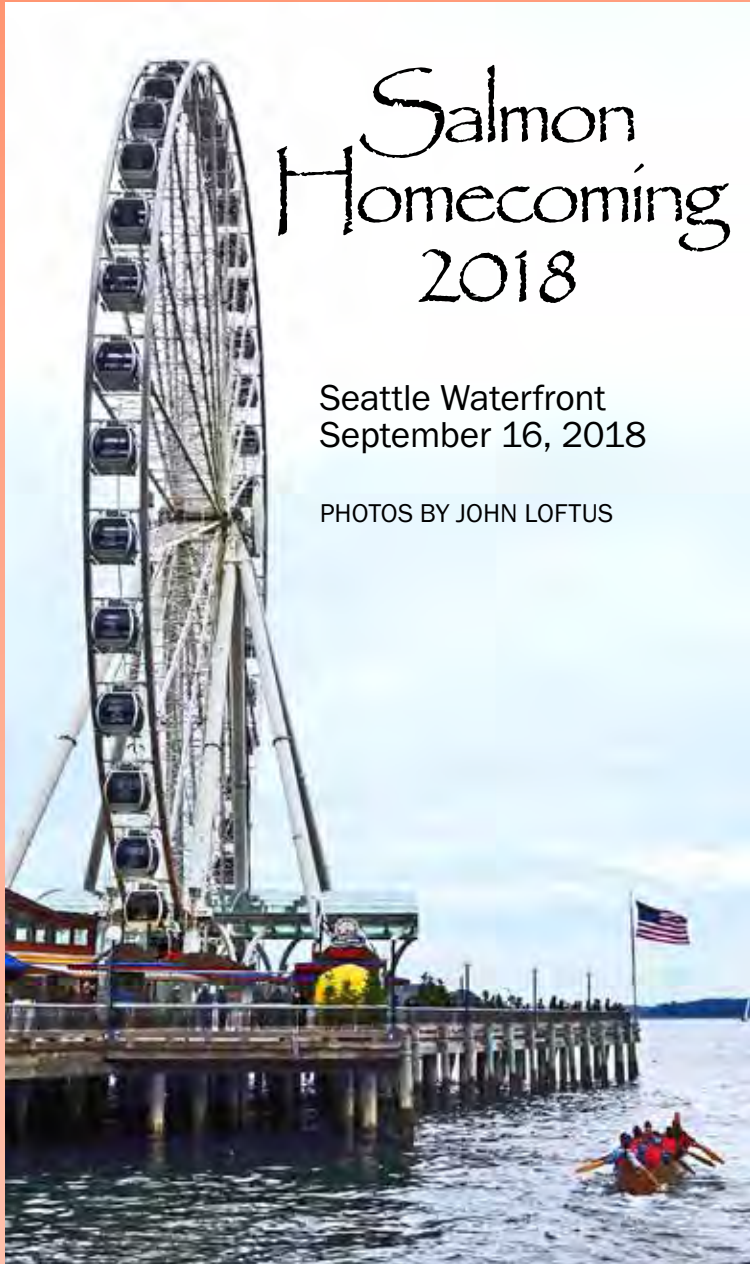

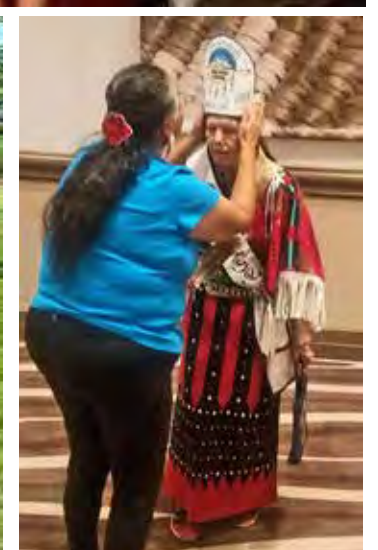



### \$45,000 Housing Assistance Program – Increased to \$90,000 per Tribal Member

The Tribe's commitment to providing housing opportunities to its members is once again exemplified with recent policy changes to the \$45,000 Grant Program. Tribal Council recently approved that the \$45,000 Grant Program be increased to \$90,000 per Tribal member. These funds can be used for home ownership activities including down payment, mortgage reduction, home improvements, self-help and safe housing repairs. In addition, the Tribal Housing Ordinance has been updated to allow Muckleshoot enrolled couples to each utilize their \$90,000 grant towards eligible program services for a total Grant of \$180,000. \$20,000 of each member's assistance shall be reserved exclusively for safe housing repairs.


## ELIGIBILITY:

- Muckleshoot Tribal Enrollment:** Applicant must be a Muckleshoot Tribal member at least eighteen (18) years of age and enrolled in the Muckleshoot Indian Tribe for a minimum of five (5) years or be enrolled in the Muckleshoot Indian Tribe and have resided within the Muckleshoot Reservation their entire life.
- Proof of Ownership:** Applicants must provide proof of ownership for the assisted property and utilize the home as their primary residence.
- Proof of Insurance:** Applicants must provide proof that the assisted property is covered by an insurance policy or sign a Homeowners Insurance Acknowledgment.
- Release of Information:** Applicants must sign a Release of Information to allow the Muckleshoot Housing Authority to obtain and verify information relative to eligibility for assistance.
- Residency/Payback Agreement:** Applicants, including any additional parties with ownership of the assisted property, must sign a Residency Payback Agreement agreeing to payback terms and refinance restrictions during a five (5) year payback period.

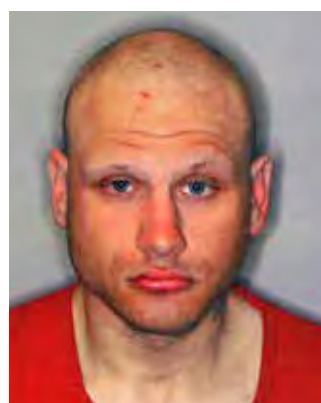

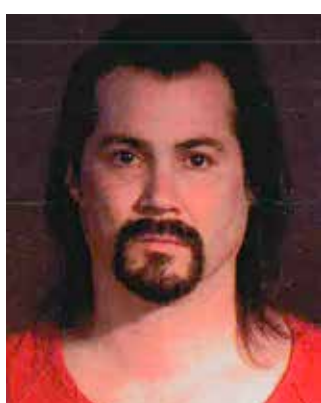

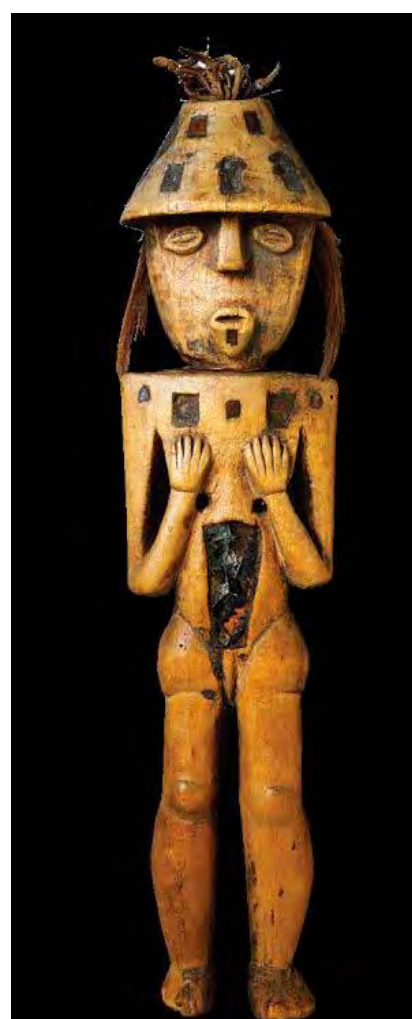

**Free Legal Services for Native American Victims of Domestic Violence and Other Crimes**

**Northwest Justice Project's** Coordinated Legal Education Assistance and Referral program (CLEAR) has new services available for Native American crime victims through the **CLEAR-CV-Native American Program**. An NJP attorney is available to provide advice, brief services and referrals in civil (non-criminal) legal matters stemming from the client's experience as a crime victim.

**Examples of legal problems include:**

- Family Law** matters such as divorce, custody and protection orders involving domestic violence or sexual assault, especially when the case is in tribal court or the client believes it should be in tribal court; or when tribal court orders are not enforced.
- Health** matters including denial of health care services or assistance in obtaining mental health services to deal with victimization
- Housing** problems such as evictions or needing to break a lease due to a crime in the home
- Economic security** issues such as medical bills, utility access and other consumer problems caused by an assault, abuse, or fraud.
- Other** legal problems resulting from being a victim of crime

If you are a Native American crime victim seeking legal assistance, ask a tribal service provider or a staff member of an organization that serves Native Americans for a referral. Social services staff or tribal advocates refer clients to the CLEAR-CV-Native American program by sending a referral form.

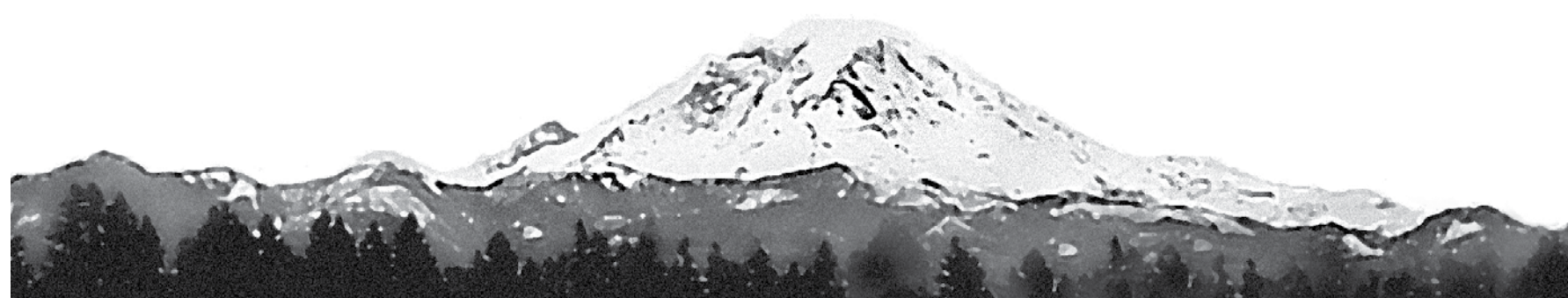

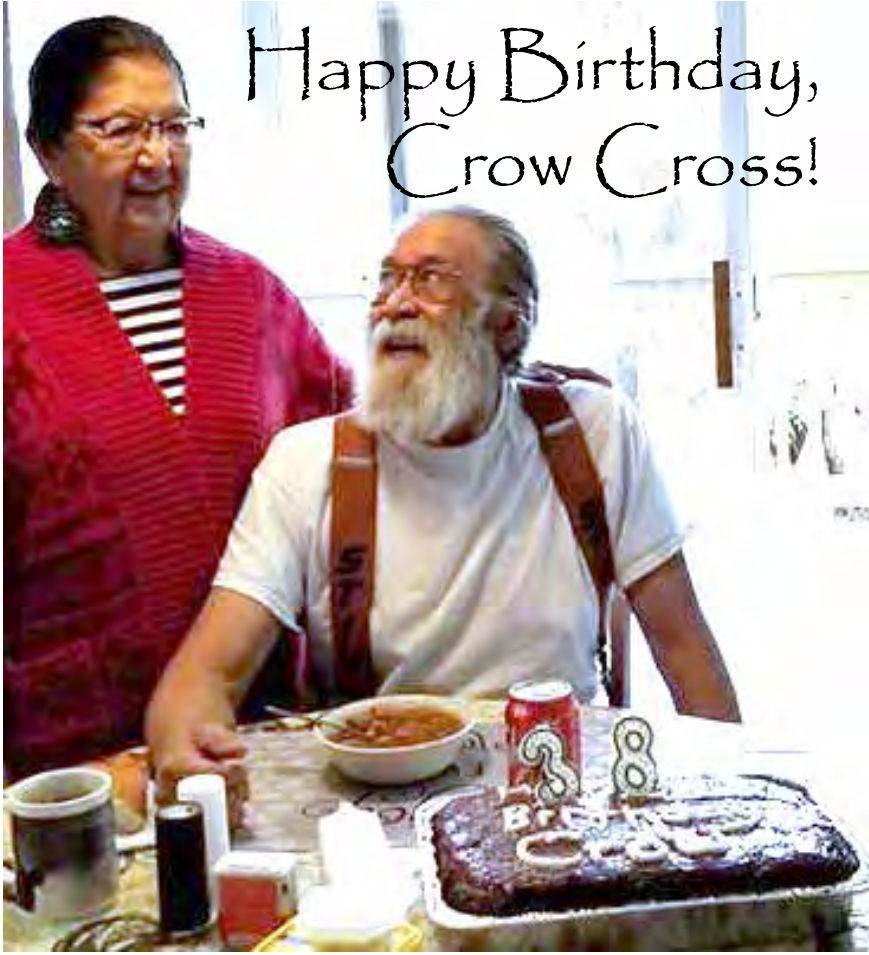
