



# Echoes of 1855 Treaty War ripple through Puget Sound tribes today

Every Nisqually, Puyallup and Muckleshoot citizen today owes a debt of gratitude, which can never be repaid, to our extended family of warriors whose courage and valor resulted in the return of nearly 25,000 acres of Indian land to Our People.

When foreigners came to my Ilalqo village, my Old Ones fed them and expected them to be on their way. They refused to leave.

They had no claim of title, as Muckleshoot land wasn't ceded to the United States until 1859. Neither of our treaties provided a reservation for Muckleshoot. We had no choice but to stand our ground.

The war was won as a result of an alliance of extended family stretching in a great circle on both sides of the mountains. Most of our warriors survived the war, were allotted land and had big families with thousands of descendants today.

Nisqually, Puyallup and Muckleshoot came together again for the second Treaty War a century later – the war to protect our treaty fishing rights. The front-line warriors of the fish war were almost all direct descendants of the warriors of the first treaty war.

Washington Gov. Isaac Stevens capitulated at Fox Island on August 4, 1856 when he announced, "You shall have a large reservation at Nisqually, one large reservation on the Puyaloop. Those reservations shall give you ground enough for horses and to the Horse Indians, Muckleshook I will give land between White and Green Rivers and I will send a man with you to mark out the ground so that you may be satisfied."

#### **COMCAST COMES TO MUCKLESHOOT**

The Muckleshoot Tribe wishes to formally announce that its ongoing project to provide high speed broadband service on the reservation is nearly complete. The \$3 million collaboration with Comcast will bring a full suite of Internet, TV, wi-fi and other services to more then 600 homes and businesses.



The project met with delays caused

by complex issues that arose such as rights-of-way and the use of existing poles, but with the pandemic making the need for reliable high-speed broadband service for in-home learning and other necessities a top priority, these obstacles were overcome. Final completion is expected in the next few months.

"Bringing reliable high-speed broadband service to Muckleshoot has long been a priority for the Tribal Council, and we believe that this will be a major step forward for our families and the future of our community," Tribal Council Chair Jaison Elkins said.

## It Takes a Village: Muckleshoot Fights the Pandemic

By any measure, the Muckleshoot Tribe has done an exemplary job of fighting the pandemic, and it's been a classic example of the "It Takes a Vil*lage" concept – or, in this case,* "It Takes a Tribe." So many people, so many different departments, so many volunteers have stepped forward that an earnest effort to compile a list of all of them was unsuccessful. So, not wanting to honor some if every person involved cannot be honored, no list will be published. But you all know who you are, and each and every one of you is a hero. Here is an account of MIT's response to the pandemic from the perspective of HWC Clinic Manager Jeremy Pangelinan, who has been on the front line of the front lines.

As a result of the first report-



ed death in Washington State from the Covid-19 virus on March 1, 2020, the Tribe activated a united response through the Office of Emergency Management, creating the Emergency Operations Center. The Emergency Operations Center (EOC)

consisted of multiple departments in the Tribe, one of which is Emergency Support Function 8 (ESF8), which is Public Health and Medical Services, the department that I'm responsible for.

We'd done training exercises

for this type of event in the past, but never at this level. We quickly became overwhelmed, so it had to be a very rapid learning process. Early on, we enlisted the assistance of an outside emergency management agency to help the manage the flow of *Continued on Page 6* 

# **Muckleshoot Donates Covid-19 Vaccine to Department of Corrections for Tribal Inmates**

Realizing that many tribal members who are incarcerated will return to the communities in which they received their criminal conviction, the Department of Corrections continues to find ways to bring the incarcerated Indigenous people closer to their cultural roots.

Recently, a unique opportunity was presented in an unexpected way. In February 2021, Jeremy Pangelinan, Muckleshoot Tribe's health clinic manager, reached out to the Governor's Office of Indian Affairs to express the Muckleshoot Tribe's interest in gifting a portion of their allocated COVID-19 vaccine

their allocated COVID-19 vaccine doses to incarcerated members of the Muckleshoot Tribe.

Through this connection, Pangelinan was placed in touch with Jeremy Barclay of the DOC's Tribal Relations Office, who collaborates with Native tribes across the state to assist in providing pro-social connections for Indigenous incarcerated people.

Together, Pangelinan and Barclay worked with both the Washington State Department of Health and the DOC's own Health Services to ensure that the gift of COVID-19 vaccine doses could be delivered to currently incarcerated members of the Muckleshoot Tribe who, had they not been incarcerated, would otherwise have had the opportunity to receive these vaccines from the Tribe.

"COVID-19 is a potentially life-threatening illness," Barclay said. "This act of compassion from the Muckleshoot Tribe reflects the importance of pro-social connections between a home community and its incarcerated people."

In total, 17 incarcerated individuals met the criteria of being members of the Muckleshoot Tribe and were eligible to receive the vaccine doses. And so, on a snowy day in mid-February, Pangelinan and Barclay each drove to the Monroe Correctional Complex (MCC) to hand off the gift of the potentially life-saving vaccine. Of the 17 eligible individuals, 14 consented to be vaccinated with the Moderna vaccine..

"We are grateful for this opportunity to assist with the vaccination effort," Tribal Council Vice-Chairman Donny Stevenson said. "This represents MIT's concern for ALL of our Tribal members during the pandemic."

"By graciously providing the COVID-19 vaccine to the incarcerated members of their community, the Muckleshoot Tribe set an example for what communities could strive to achieve," Barclay added. "The Tribe has demonstrated that, even though an individual might be incarcerated for awhile, they still have a home to which they belong."

## First Native American Secretary of the Interior

"I, Debra Haaland, do solemnly swear that I will support and defend the Constitution of the United States against all enemies foreign and domestic; that I will bear true faith and allegiance to the same," said Haaland, a citizen of the Pueblo of Laguna.

Our new Secretary of the Interior, the first Native American ever to serve in a President's cabinet, is seen above taking part in a ceremonial swearing-in at the White House complex on March 18, 2021.

The oath of office was administered by Vice President Kamala Harris, who is a history maker herself. Of Black and East Indian descent, she is the first female to serve as Vice-President of the United States. Daughter Somah Haaland proudly held the bible while her mom took the oath. Two of her sisters were also present.

Haaland was confirmed by the U.S. Senate as Secretary of the Interior on March 15 by of vote of 51-40. Later that day, President Biden issued the commission of appointment for Haaland, and on March 16, she resigned her seat in the U.S. House of Representatives after delivering her final floor speech.

On March 17, Deb Haaland began serving as the 54th Secretary of the Interior. For Indian Country, it was a dream come true to have a Native overseeing the federal agency charged with administering most of the government's trust and treaty responsibilities.

Dear fellow Muckleshoot Tribal members, These are momentous days in Indian Country, as well as here at Muckleshoot and in the United States in general. I want to touch on a few topics, some national and some local:

NEW INTERIOR SECRETARY. Deb Haaland, an enrolled citizen of the Pueblo of Laguna, has been sworn in as the new U.S. Secretary of the Interior, becoming the first Native American to serve in a President's Cabinet. Interior is a huge department that oversees not only the Bureau of Indian Affairs, but also the management of all federal land and resources except for the National Forests,

which are within the jurisdiction of the Department of Agriculture. Formerly a Congresswoman from New Mexico, Haaland's leadership, record of advocacy for indigenous people and commitment to improving the relationship between that agency and tribal nations is great news for Indian Country. We've met with her in Washington, DC in the past,

have formed a good working relationship. We look forward to seeing meaningful progress on many fronts during Secretary Haaland's tenure.

Majority Leader Chuck Schumer said, "Haaland's appointment will help repair the relationship between the Interior Department and tribal nations that have not been treated fairly by that agency." We look forward to working with Secretary Haaland as she leads this crucial agency into a new era of cooperation with and support of tribal nations.

MUCKLESHOOT/COMCAST BROADBAND PROJECT. I also wanted to update you about a project we've been working on for a few years here on the reservation. In cooperation with Comcast, we are now in the final stages of completing a \$3 million project to bring high-speed broadband service and all that comes with it to about 600 tribal homes and businesses.

The project was slowed down by issues pertaining to right-of-way and access to existing power poles, but we are anticipating that it will be up and running within the next few months. In-home schooling during the current pandemic made the need for this service all the more urgent, and we are happy to finally see it nearing completion.

ASIAN-PACIFIC ISLANDER RACIAL HATRED. Finally, I want to express deep concern over the very real issue of racial hatred and violence that has once again been in the news. The horrific shooting of eight people, including six Asian women, in Atlanta reminds us all of the violence, discrimination and intolerance faced by our Asian and Pacific Islander brothers and sisters, and we have made it clear that the Muckleshoot Tribe stands in solidarity with them.

The Atlanta shootings have captured the nation's attention, but violence against Asian-Americans – particularly elders – has become disturbingly common, including right here in the Seattle-Tacoma area. We strongly condemn the violence, hatred, and discrimination that this community, and all communities of color, face every day. We need to stand strong together and celebrate the strength that comes from cultural diversity.

In closing I wanted to remind everyone that while we have made good progress with our vaccination program and public health protocols, the COVID virus is still with us. We all need to keep practicing the public heath guidelines of mask wearing, frequent hand washing and social distancing. If we all do our part we will soon get through these challenging times and once again be able to gather together with friends and family and as a Tribal Community.

I wish you all good health, peace, and warm wishes.





He enjoyed tormenting the neighborhood kids even as an adult whether it would be his family or neighborhood children in Kerman, where his sons grew up. Joey was banned by his son Stephen from chaperoning school field trips because he would cuss and yell at the kids for walking too slow and in turn he told the teacher so they could get detention for not listening to him. This embarrassed his son Stephen, but definitely a memory to be cherished forever.

Joey was a character and very funny. He always had a story to tell. You never knew what stories to believe, but he sure was great at telling them. Joey was known for giving nicknames, including his daughter Sarah AKA Doogs, who he loved very much.

and dogs. During his lifetime he gained some awards as well, including veterans. Crow and Henry King George even won a hunting case.

George is survived by sons James Cross Sr., Gerald Cross and Gary Cross; daughters Rosette Andy and Mitzi Judge; stepson Kenneth Foreman; sisters Virginia Cross, Mildred Jones, Marlene Cross, and Lorraine Cross; numerous grandchildren and great-grandchildren; even his cat Baby. #### **Teddy Emery**



Good afternoon everyone, my name is Jaison Elkins, and I have the privilege of serving as Chair of the Muckleshoot Indian Tribal Council.

It is a distinct honor to be here with you all to share in today's historic event. The Mud Mountain Dam Fish Passage Project represents many years of hard work by so many. I want to take a moment and specifically thank Senator Murray for her tireless leadership, the Army Corps for their dedication, the Puyallup Tribe for their collaboration, the Muckleshoot Fish Commission, our staff and tribal members for your passion to see this project through.

The Muckleshoot Tribe has a responsibility to White River salmon, especially our precious White River Spring Chinook. We have advocated for safe fish passage and reliable water supply to our hatchery for many years. This item has been one of the major aspects of our federal advocacy agenda for many years. We saw how the old fish passage facilities were killing the salmon rather than assisting them on their journey upstream to spawn.

Through all these years, we have watched this project continue to move forward, thanks to the efforts of many here today. We now look forward to the completion of the new surface water supply for our hatchery so the production of ESA listed White River Spring Chinook is protected.

Today's event celebrates the largest fish passage facility in the United States and stands as a testament to what can be achieved when federal, state, local, and tribal partners join together and commit ourselves to the important goal of restoring salmon populations to sustainable harvestable levels

The cooperation that has made this important project possible stands as an example of what can be achieved when we share that commitment and work together toward our common goal of saving our region's salmon populations. It is this collaborative approach the Tribe wants to bring to



bear on other critical salmon enhancement issues in the urban environment, like the serious challenges currently facing the Lake Washington sockeye.

Our culture is linked with the salmon, and we stand committed to continuing our fight to save and restore this important Northwest resource. We are not done. We look forward to many years of continued coordination with the Army Corps on the operation of the new Passage Facility and fulfillment of the needs at our hatchery.

Thank you all again for joining us on this historic day.



# **Jacinta Migo becomes first female American Samoan Chief Master Sergeant in Air Force**

OKALOOSA COUNTY, Fla. – History was made at Hurlburt Field earlier this month. Senior Master Sergeant Jacinta Migo became the first American Samoan woman to be promoted in the U.S. Air Force to the rank of Chief Master Sergeant.

The 505th Test and Training Group, headquartered on Hurlburt Field, hosted the historic first on Feb. 1. Migo's family and colleagues watch live and via streaming video as she joined an elite group of senior listed that is only attained by 1% of the enlisted.

The Air Force base says Migo is the first American Samoan woman to be promoted to this rank, and may be the first American Samoan ever to achieve the rank

American Samoa is a U.S. territory covering five South Pacific islands and two atolls, which is slightly larger than Washington D.C. It is the home to just over 50,000 people. Living in such a small area meant that "our culture focused on God, family, respect, service, and love," Migo says.

Migo was her high school class valedictorian and joined the Air Force in 1998 because she met the service's highest test score requirements on the Armed Services Vocational Aptitude Battery.

During the ceremony, Col. Francisco Gallei, 505th Test and Training Group commander, noted that Migo was a highly accomplished Airman who has received many accolades over her career.

"Not only has she been recognized with two major command-level awards, one in Pacific Command and the other in North American Aerospace Defense Command, as their Command and Control Battle Management Operator of the Year," Gallei announced, "she was also the Air Force-level award winner last year."

Though Migo looks back fondly on her career, she says she was not a perfect Airman in the beginning, and "it has not always been an easy journey." She had many leaders, mentors, and family intervene and challenge her to be a better Airman. Her key to success and advice to Airmen is to be "persistent, be resilient, and to have humility."

This advice is in line with this Samoan proverb and words of encouragement Migo shared to other American Samoans: "E iloa le Samoa i lona tu, tautala, ma lona savali," – translated: "You know a Samoan by the way he/she stands, speaks, and walks." Migo summarized this with, "be proud of your culture and where you come from. Never give up on what you deem important; when you fall or hit a road-block, get back up and try again or re-evaluate and then press on."

Migo is currently serving as the superintendent of the 505th Test and Training Group. She is the principal advisor to the group commander on all enlisted matters and informs the commander on issues affecting the health, morale, welfare, training, and the proper utilization of over 500 personnel assigned to four squadrons, three detachments, and six operating locations.

#### **NEW MUD MOUNTAIN DAM FISH PASSAGE FACILITY**


The new Mud Mountain Dam Fish Passage facility replaces one that was constructed in 1947 around the same time that Mud Mountain Dam itself was constructed just six miles upstream. That fish passage facility was designed to trap and haul up to 20,000 fish per year, to be released back into the White River above the dam. The new facility is capable of



trapping and hauling three times that many – 60,000 fish – in a single day, and up to 1.25 million fish per year, making it the largest trap-and-haul fish passage facility in the nation.







# Judge rules national archives will stay in Seattle for now

# With the support of tribes, lawsuit successfully halts sale


When expedited plans to sell Seattle's National Archives building first surfaced in January, dozens of tribes joined Washington Attorney General Bob Ferguson's lawsuit to stop it. It worked: On Friday, February 12, a judge granted a preliminary injunction to keep the National Archives building in Seattle — for now.

The judge's order halts the imminent sale of the building and removal of archival documents. A written order filed Tuesday morning details the decision, explaining that the federal government can't move forward with the sale until the court issues an ultimate determination, which could be some time away.

"This was a gigantic victory," says Brandon Reynon, historic preservation officer for the Puyallup Tribe. "But we've still got a lot of work to do."

The injunction was issued by U.S. District Judge John Coughenour, who last Friday chided the Public Buildings Reform Board, the federal entity behind the proposed sale. He described the situation as a "public relations disaster" that could have been avoided if the board had handled the case with more sensitivity.

Ferguson says this was a glaring issue he had with the sale from the beginning. He describes the rushed process as one that, at minimum, conveyed a level of obliviousness of a move's potential impact on tribes

and the region.

"They just don't have a clue, and they don't seem to care, honestly," Ferguson says. "Few things anger me more than that. They don't know what they're doing."

The archives hold significance throughout the Pacific Northwest, containing the personal histories of many of the region's communities. The documents and material are particularly important for tribes, many of which depend on the information held to inform everything from genealogical records to drafts of tribal treaties.

In the lawsuit, Ferguson argued that the building was ineligible for a rushed sale process in the first place, and that the federal government failed to complete the required step of consulting tribes during the process. Coughenour also referenced that on Friday, discussing the lack of communication with tribes and acknowledging that he "was unhappy with the way this entire process was handled," according to Ferguson.

While the sale is paused, the judge's order alone doesn't stop the board from trying to sell the building again. Reynon says this is fine, as long as it's done with tribal consultation. This could take a while, given that Seattle's National Archives building serves at least 272 federally recognized tribes spread throughout its coverage area.

"Whether the building goes, stays, whatever, that's not the point right now," Reynon says. "Consultation needs to still take place, so we'll be eagerly waiting for that consultation to take place as soon as possible."

He adds that "the time that it takes is their fault. It's their own rules, and we're holding them accountable to their own rules that they are required to do."

The fate of the Seattle-based collection of archives remains undecided. "The legal victory... helps buy time for our federal delegation and the federal government to find a permanent solution," Ferguson says. "And that is going to be needed."

## It Takes a Village: Muckleshoot Fights the Pandemic

Continued from Page 1 the EOC.

Because we had some experience with the pandemic flu, we tried to use that in the clinical side with regard to PPE (personal protective equipment) management and PPE allocations. We knew from the outset that we were definitely understaffed for this level of response.

In the beginning, it was just information gathering. We hadn't had a case at Muckleshoot, and at that time we didn't have the testing capabilities. Originally, it was a state public health lab-only test that required prior authorization, so it was a lot harder for us to get individuals tested for the Coronavirus, even if we wanted to.

After some time, the two largest reference labs in the United States, Labcorp and Quest Diagnostics, started to offer the testing and we started sending our own samples in for testing. We started slowly. In the beginning, it was pretty quiet – dormant, no positives.

There were a few months when people – or the government, – didn't really know what the proper recommendations were, and we weren't sure if the virus was airborne or if droplets on surfaces were the main concern. There were so many unknowns and what-ifs, because we were literally learning as we were going along; and all the while the cases were blowing up in Wuhan, China.

As time went on, we continued to get the message out to the community to try not to gather. And unfortunately, because we are a tribal community and we still have to live, we still have to associate, and we still need to take care of our elders and our children, we continued to live at status quo, and this started to show in our numbers.

We started to get positive cases. We started to see some small clusters, and the clusters were identified in families – multi-generational households where there are five, six, seven people in the home – parents who work at one entity, kids going to the same school, etc. – and they were just kind of passing the virus around, which caused our numbers to start to grow.

The Tribal Council declared a public health emergency and continued to work to make sure the information was distributed to the community. The directives included instituting a mandatory mask policy, social distancing and other precautions to help mitigate the continued exposure and transmission of

the Coronavirus.

Fast forward a year: With the availability of the first emergency use authorized vaccine, which was the Pfizer vaccine, the Tribe was able to be one of the first tribes to use the State of Washington to get our first shipment of vaccine. That happened in the late fall of 2020, and on December 18 we carried out our first mass vaccine clinic.

Since then, we've run a total of two complete two-dose vaccine clinics – complete, meaning a primary dose and a booster dose. We've vaccinated pretty close to 3,000 tribal members, household members, community members and tribal government employees that had ties to the tribe.

With the availability of a second authorized vaccine, which is the Moderna vaccine, we've been able to do weekly, regular half-day vaccine clinics that are open to Muckleshoot Tribal members, as well as members who are enrolled for services in the Muckleshoot Health Center, and we continue to vaccinate weekly for both primary and booster doses.

With the authorization of the new single-dose Johnson & Johnson vaccine, we anticipate the request for future mass vaccine clinics, which will make it easier, because a one-dose is easier than a two-dose.

But let me emphasize: This has most definitely been a multi-disciplinary, multi-department collaboration. It's not just a Health Division-only mission. It has involved Transportation, Tribal Operations, Housing, Human Resources, Information Technology and the Adult Work Training Program and many volunteers.

All these programs have contributed equally to support the mission of the Muckleshoot Health and Wellness Center to help mitigate the spread of the Coronavirus and how to take care of people who do have the virus to ensure that their services and their health and care needs are met.

And, let me emphasize, this pandemic is definitely not over. Obviously, with the continued availability of new vaccines and the cooperation of all the community members, tribal members and team members, as well as the citizens of our state and the rest of the nation with regard to observing social distancing, staying home when you're sick and using your mask, we hope that it's kind of the "light at the end of the tunnel" time for us, as we continue to make positive strides to decrease the

nfection

We have shown in the last few weeks that we're able to keep our numbers down. We've had a streak of no new cases, which is great. There are no guarantees, but our hope is that this streak will continue. However, at the same time, we know that sometimes when nothing's happening, people tend to relax their restrictions, and then we may have a case or two that will pop up. But, we are prepared to address that as it comes up, and we hope to continue to get support of all the tribal members, their families and the community.

## **How the Mass Vaccination Events Worked**

The mass vaccination events are a multi-department collaboration. They were drive-though only, so starting before dawn, cars would line up on the drive around the powwow grounds. Eventually, their car would get to the testing triage tent, where the occupants are screened. They are identified by their name and their birthdate, and we make sure that they meet the minimum criteria for the vaccine. They're given a consent form. Their temperature is taken, at which point then they are flagged on to the vaccine administration lane.

That lane is staffed by clinical Medical Assistants as well as admin staff who double-check the eligibility of the individual, making sure that we're addressing any medical concerns that they may have prior to vaccination. Finally, they reach the front of the line, alongside the Health and Wellness Center, where skilled professionals administer the lifesaving vaccine to each individual as they sit in their car.

After that, they are then flagged on to our monitoring area, which is staffed by members of multiple departments of the Tribe, where they are kept there anywhere from 15 to 30 minutes to make sure that they don't exhibit or manifest any negative symptoms of the vaccine.

If they do, we have licensed medical staff that includes physicians and advanced practitioners onsite to address those concerns when they come up, and we address everything, small and big. This is a very important point. Because the vaccine is very new and it's still in the emergency use period, the CDC wants to make sure that every possible reaction that someone exhibits is addressed and documented and followed up on.

So, we make sure that we're being mindful of that, and we encourage peo-

ple who get the vaccine while they're in their waiting period to report it to us, so that we can make sure that we address it and when they leave they feel comfortable and safe to go on with their day.

#### On the Front Line

Once the cars make their way to the front, the actual vaccination process involves the coordinated efforts of a large team of people. I have all my Medical Assistants working that event, vaccinating. So that's about five Medical Assistants.

We have three stations set up. Each station has a Medical Assistant to administer the vaccine and an administrative support staff member to do the document verification. There are three MA's and three admin staff running the process, one set for each station. Then we have a runner who runs vaccine to the three stations, and this individual happens to be a Medical Assistant as

And then we have two dedicated Medical Assistants in another tent drawing the vaccines as we need them. We have two trained "draw people," and there two reasons for this. One, the vaccine is very delicate. It needs to be stored properly, and very specifically, with little deviation to that requirement for storage.

Having two staff specializing in the care and handling of the vaccine is key, because they are the only ones touching the vaccine before it's prepared. We have a portable refrigeration unit that has an alarm monitor on it that takes a sample every 30 seconds, to make sure that the temperature in the unit is suffi-

cient for the vaccine and is ready to set off an alarm if it is not.

All in all, it's a pretty well-oiled machine. We have about six or seven Medical Assistants, that many administrative staff members, and then we have two onsite lead supervisors helping just to monitor flow and ensure safety. We have vehicles coming through these lanes and the staff administering these vaccines are walking, so we have safety monitors. You want to make sure that cars are in park, ensure that staff aren't walking in front of vehicles that are not in park or that are rolling.

It's exciting. I think it takes literally 30 seconds, or maybe 45 seconds from start to finish, from the time you arrive, to the time we vaccinate you and we let you go from that station. But it takes a lot more time and effort to prepare for that in the clinical side. The pace is very fast, and the people are very happy to be getting their life-saving vaccine, so all in all, it's definitely an exciting experience.

It's also important to point out that we're doing this outside in a cold and rainy season. The elements have definitely worked against us, but I have to say how grateful we are to one of our partners in the Tribe – specifically, the Building Maintenance Department.

Literally overnight, they erected semi-permanent infrared heating systems so that my staff who are standing out there vaccinating for hours on end are kept in an environment where it's suitable and it's comfortable enough for us to be able to have pleasant conversations with people that we're vaccinating, and to laugh and joke amongst ourselves, being out there for long hours in the cold. Those heaters have made a big difference!

I really appreciate the opportunity to share this story. I know that we've been putting out information about vaccinations and recommendations by way of the Tribe's social media, but I just want to say that doing this, rising to the occasion in a time of emergency, has been a great experience, and we will continue for as long as the need exists.

The Muckleshoot Tribe figured all this out as we went along. We developed these processes as the needs arose, and it was very successful, so I want to thank each and every one of the countless staff and volunteers that have been involved, and express my deep appreciation to our wonderful community for rising to the occasion in this time of need. Thank you, one and all.

Muckleshoot Tribal College has even increased our course offerings to include a brand new Cinematography course series. MTC in partnership with the Tribal Language department developed the cinematography course together, to provide educators with the skills to make educational video content. 
(2) To act as a responsible and responsive conduit for disseminating Workshop & Training Incentives to tribal members.





- Someone in an unbalanced power situation (Someone under your authority) cannot consent
- Consent cannot be given when someone is asleep or so drunk or high that their decision making is impaired.

## It's just not that simple, Part III

Why don't they just leave? We often have that question in our minds when someone stays in an abusive relationship. Sometimes we don't even know they were in an abusive relationship until after it is over and then we question why didn't they leave earlier. This is victim blaming. Instead our question should be how does the abuser who is hurting them emotionally or physically prevent the victim from leaving?

Here are some examples of what an abuser might say to a victim to get them to stay:

- If you do that, I'll hurt you.
- If you leave me, I'll take the kids away.
- If I find out you've been unfaithful, I'll have to kill you.
- I'll make sure I get the house/car/business and you'll be left with nothing.
- If you try to leave, I'll hurt you, the kids, the pets or other family or friends.
- Don't leave me. I'll have to kill myself.
- You really think anyone would believe you over me?
- Do you really want me to tell everyone what you're like?
- What are you going to do live on the street?
- Do you think anyone else is going to want you with all those kids?
- Are you really going to take the kids away from their father? You are so selfish.
- I could tell the community members/friends about your mental illness/secrets.

The list is endless of ways an abuser can intimidate a victim into staying. The most important thing we can do for someone in an abusive relationship is stop victim-blaming. Let the victim know that you will support whatever their choice is, but you are worried about them and hope they will get help. Then learn more about how to help your friend or family member by making an appointment with the Muckleshoot Victim Services Program. The program isn't just for victims of crime, but for family or friends to find how they can support and assist those they love.

## **Hydration and Pregnancy**



#### Did you know that drinking lots of water during pregnancy is important?

Pregnant women should drink approximately half of their body weight in water. For example, if you weigh 160 pounds, it is suggested that you drink about 80 oz's of water. That's a lot of water, but there are lots of benefits when you do! Here are just a few of them:

- It helps to prevent pre-term labor (going into labor before your baby is ready)
- It helps to produce the right amount of amniotic fluid (the fluid your baby is living in). Too low of levels of amniotic fluid can lead to decreased development of the baby
- It helps with digestion of your food and makes constipation better
- It helps to increase your blood volume, which you need for delivering your baby
- It helps your body produce breastmilk to feed your baby

SO... think about increasing your water intake if you are pregnant. There are lots of great benefits when you do. And, here is a tip... If you don't like to drink plain water, think about adding some fruit in it to give it a yummy flavor.



FAMILY AND YOUTH SERVICES / BEHAVIORAL HEALTH - Family and Youth Services / Behavioral Health, has continuously been open via telephone throughout the COVID crisis. We have provided both Mental Health and Chemical Dependency Counseling via Zoom and telephone and face to face when possible.

As of July 28th, we reopened our office. Clients will make appointments through their provider. When they come to the HWC building, they are asked to screen in through the medical tent and wait for their provider at our side door. We are minimizing bringing clients into the office and are opting for outdoor choices whenever possible.

We have reopened Equine Services for current clients, including individual and small groups, and we are utilizing outdoor spaces at the barn for other meetings. We will continue to prioritize Zoom and telephone meetings when possible, for older youth, this can be a preferred method of meeting.

We continue to maintain a high level of compliance to Social Distancing measures, including 6', mandatory masks and frequent Hours & Contacts. We are available by phone during regular business hours, 8-5, M-F, 253.333.3605, for consultation or to

discuss accessing both Mental Health and Chemical Dependency services for youth and families who are in need.

BEHAVIOR HEALTH – All of our Substance Use Disorder Case Managers and our Gambling Counselor are all back in the office as well. We are providing face-to-face assessment services and face-to-face, zoom, and phone individual sessions. All of our <u>Intensive Outpatient Programs</u> (IOP) and <u>Wellbriety</u> and <u>Seeking Safety</u> outpatient groups are holding in-person

groups (with social distancing precautions) again as well as continuing with Zoom groups at their regularly scheduled times.

Program update for the Medical Clinic, Optical Clinic and Community Health Program: During the current pandemic our programs will be open but with limited hours and services which are as follows: The Medical Clinic is open Monday through Friday from 8 am to 5 pm. <u>WIC</u> services are available by phone at 206-263-2460. Our Community Health Program is still closed during this time.




When I was offered the Staff Trainer job for the MEIHSS department I was so excited! This is my dream job, I get to do what I love at the tribe, our own tribe at that!

The most important lesson they taught me was to always respect your elders. Elders have been through so much and are so wise. I love hearing the stories they like to share and they give good advice. I like asking them questions about the tribal history or about the language... well, just about anything in general. They have so much knowledge

#### \$45,000 Housing Assistance Program Increased to \$90,000 per Tribal Member

The Tribe's commitment to providing housing opportunities to its members is once again exemplified with recent policy changes to the \$45,000 Grant Program. Tribal Council recently approved that the \$45,000 Grant Program be increased to \$90,000 per Tribal member. These funds can be used for home ownership activities including down payment, mortgage reduction, home improvements, self-help and safe housing repairs. In addition, the Tribal Housing Ordinance has been updated to allow Muckleshoot enrolled couples to each utilize their \$90,000 grant towards eligible program services for a total Grant of \$180,000. \$20,000 of each member's assistance shall be reserved

## **ELIGIBILITY:**

An NJP attorney is available to provide advice, brief services and referrals in civil (non-criminal) legal matters stemming from the client's experience as a

#### Examples of legal problems include:

(5) year payback period.

- Family Law matters such as divorce, custody and protection orders involving domestic violence or sexual assault, especially when the case is in tribal court or the client believes it should be in tribal court; or when tribal court orders are not enforced.
- Health matters including denial of health care services or assistance in obtaining mental health services to deal with victimization
- Housing problems such as evictions or needing to break a lease due to a crime in the home
- Economic security issues such as medical bills, utility access and other consumer problems caused by an assault, abuse, or fraud.
- Other legal problems resulting from being a victim of crime

Visit the Muckleshoot CCDF program at the Muckleshoot Early Childhood Education Center, located on the Tribal School Campus (15599 SE 376th St Auburn, WA 98092) and request a CCDF Home Provider Application.

Fill out the application completely and attach all required documentation including a copy of your first aid/CPR card, a valid picture ID, background check questionnaire & forms, completed W-9 form, and a copy of your social security card (front and back.) Submit completed application to the Muckleshoot CCDF office

(must have original application – no faxed applications accepted.) A CCDF representative will contact you within three business days to notify you about the status of your application review and/ or to coordinate pre-screening. Once pre-screening requirements are met, a home-health, and safety inspection will be performed at the residence where childcare will take place.

Upon a cleared inspection you will be eligible to care for approved Muckleshoot CCDF Families.



- Is your child(ren)? > 12 years of age or younger
- Enrolled in a federally recognized tribe or a descendant (parent must be enrolled) of a federally recognized tribe

Are you in need of respite care (income guidelines do not apply)?

- > for a child/ren placed by State Child Protective Services- ICW or the Muckleshoot Child, Family Services (MCFS) Program,
- > for a child/ren needing specialized or a high level of care

Child care is based upon your family size and monthly income that is at or below 85% of King County's median income (100% for Muckleshoot Tribal Members). You may qualify, if your family's monthly income falls below the following income range;

#### Tenant Rights During COVID-19 Pandemic Washington State Landlord Requirements

The COVID-19 Pandemic has resulted in financial distress to many families. Job losses, unemployment, and reduced hours can make paying rent difficult. Washington State has issued several Proclamations during this time to provide extra protections to tenants to assist in preserving housing. Effective immediately, and until June 4, 2020, please be aware

#### Notices to Vacate & Evictions

Landlords currently cannot serve, enforce or threaten residents with notices to vacate the premises. This includes resident's whose contract has expired or will expire during the Proclamation period. The tenancy would continue on a month-to-month basis

Your landlord can take action if your household has engaged in activities that threaten the health or safety of the neighborhood or dwelling unit.

#### Charging Late Fees

Landlords currently cannot charge, or threaten to charge, late fees for the non-payment of rent or other charges associated with a rental unit. This applies to any fees that have occurred on or after February 29, 2020. Landlords cannot attempt collection through agencies, unlawful detainer or other judicial actions, withhold any portion of security deposits or report debts to credit bureaus. Residents and landlords must work together to establish reasonable payment plans based on the individual's financial, health, and other circumstance

#### Rent or Deposit Increases

Landlords cannot increase your rent or deposit at this time. This applies to contract renewals and month-to-month contracts. The rent charged on April 15, 2020 should be the rent charged today and through the Governor's Orders. If you were charged an increased rent after this date, you are entitled to a refund of the overpayment.

If you are unable to pay your rent, make sure you communicate with your landlord. If you are not materially affected by COVID-19, you must continue to pay rent to avoid unnecessary and avoidable economic hardship to landlords, property owners, and managers.


