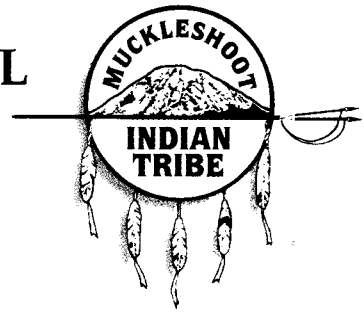

ORDINANCE NO. 21-130

TO ENACT A RECODIFIED VERSION OF TRIBAL CODE AND REPEAL ALL PREVIOUS VERSIONS OF THE TRIBAL CODE

WHEREAS, the Muckleshoot Indian Tribal Council is the duly constituted governing body for the Muckleshoot Indian Reservation by the authority of, and is herein acting solely pursuant to, its constitution and by-laws approved May 13, 1936, by the Secretary of the Interior, as amended June 28, 1977, and not pursuant to its Indian Reorganization Act Corporate Charters; and,

WHEREAS, the Muckleshoot Indian Tribal Council desires to enact a revised, reorganized Tribal Code;

WHEREAS, the Muckleshoot Tribe has reorganized all of its codes and ordinances to have systemic formatting and has corrected multiple typographical errors;

NOW THEREFORE BE IT FURTHER RESOLVED by the Tribal Council of the Muckleshoot Indian Tribe that the following codes are repealed and replaced in their entirety by the attached USB Device (labeled Recodification) re-codified version of the Muckleshoot Tribal Code:

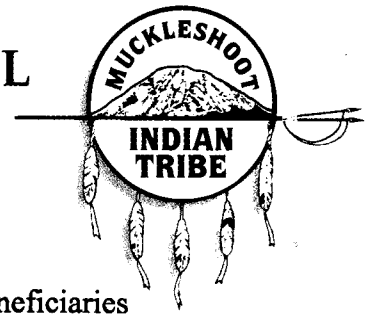





